- SUBJECT: Instructions for the Determination of which Annual Fiscal Report (AFR) to Prepare

Attached is a list of entities included in the Comprehensive Annual Financial Report for the State of Louisiana (CAFR), along with the various AFR packet types. Find your entity's name and follow across to the column that contains an "X" to determine which packet you should complete for the period ending June 30, 2014.

All AFR packets are now available on OSRAP's website. Once you have determined which AFR packet is applicable to your entity, that packet may be accessed via the internet at www.doa.louisiana.gov/osrap/index.htm.

The report for the fiscal year ending June 30, 2014 can be located by selecting "AFR packets" within the "Information" box, then scrolling down and selecting the applicable AFR packet. Each individual AFR packet includes specific instructions applicable to that packet.

Also, available on OSRAP's website is the Appendices Packet for fiscal year 2014 (see http://www.doa.louisiana.gov/OSRAP/afrpackets.htm). The appendices should be used as a reference for the various AFR packets; however, not all of the appendices are applicable to all of the reporting entities.
