GOVERNOR'S MESSAGE

Mr. President, Mr. Speaker and Honorable Members of the Legislature:

Today, I submit to you my 3rd Executive Budget as Governor of Louisiana: The Executive Budget for Fiscal Year 2027, which begins on July 1, 2026.

Working together we have made tremendous progress for the great people of Louisiana:

- The largest tax cut in state history, allowing our citizens to keep more of their hard-earned money.
- Dramatic new private sector investments in the billions and billions of dollars to grow our economy, increase wages, and provide new jobs for our citizens and future generations to come.
- An education ranking which has improved from 49th to 32nd in the country, the best ranking in Louisiana history and the most improved compared to every other state.
- Reductions in violent crime so our communities are a safer place to live and raise a family.
- Insurance reforms so we now have some rates that are coming down, rather than going up.
- Bridges are getting fixed and our infrastructure is improving.



On top of this progress, I recently announced that my ongoing efforts for fiscal accountability and program improvements have resulted in our ability to do more for the people of Louisiana without spikes in spending. We have canceled outdated contracts, focused on ensuring welfare dollars are only spent on those who qualify, and we are making technology improvements across the government to ensure we operate efficiently while providing the highest quality of services to our people.

And despite the fact that our government has faced the same pricing pressures as families across our state as a result of the hangover from massive inflation spikes which occurred in our country just a few years ago, I am proud to once again present a budget Flat-Funded compared to the past. And, while there are many moving parts and categories in our state's budget, I want to highlight that in this proposal:

- Total State Funding (including Carryforwards) decreased by \$1.9 Billion.
- Total State Funding (excluding Carryforwards) decreased by \$1.1 Billion.

Simply put, we can operate our government without further burdening the hard-working citizens of Louisiana.

I have said we must strive for a state government as good as our people. This new budget and our continued reforms are allowing us to build upon the goal of improving the lives of all Louisianans.

Working together, let us continue the tremendous progress we are making.

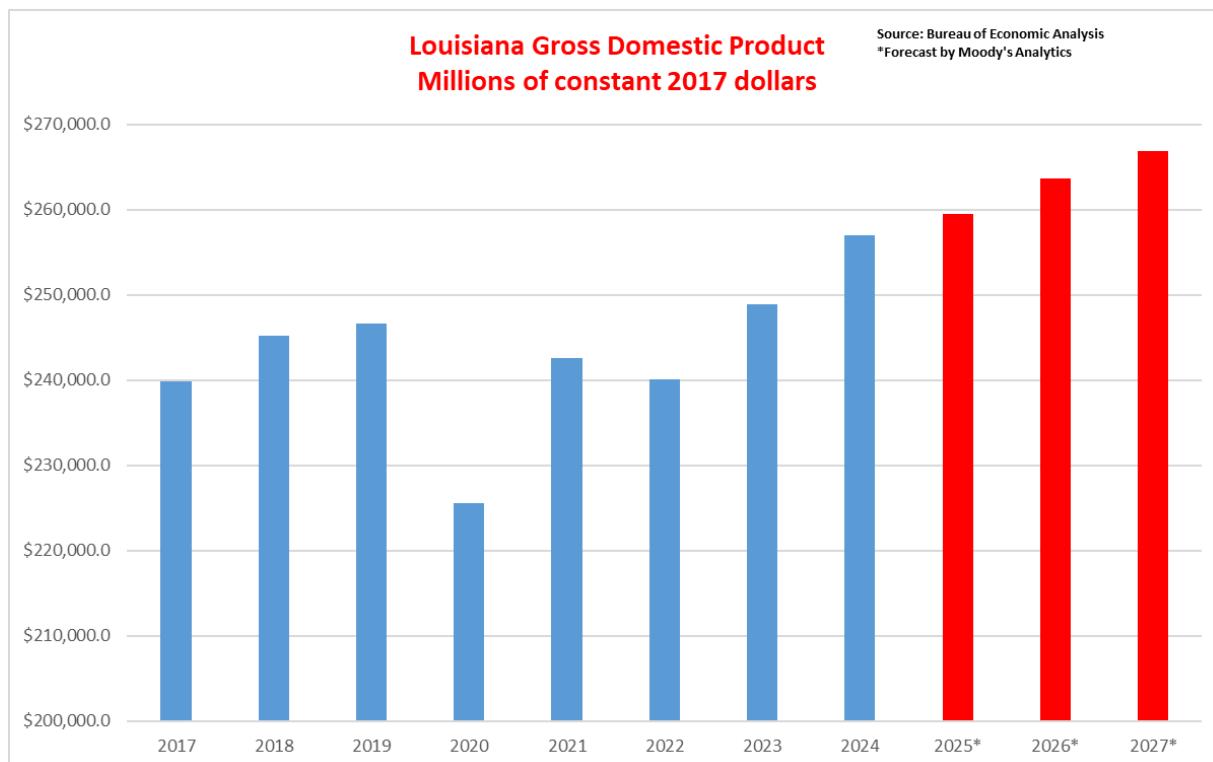

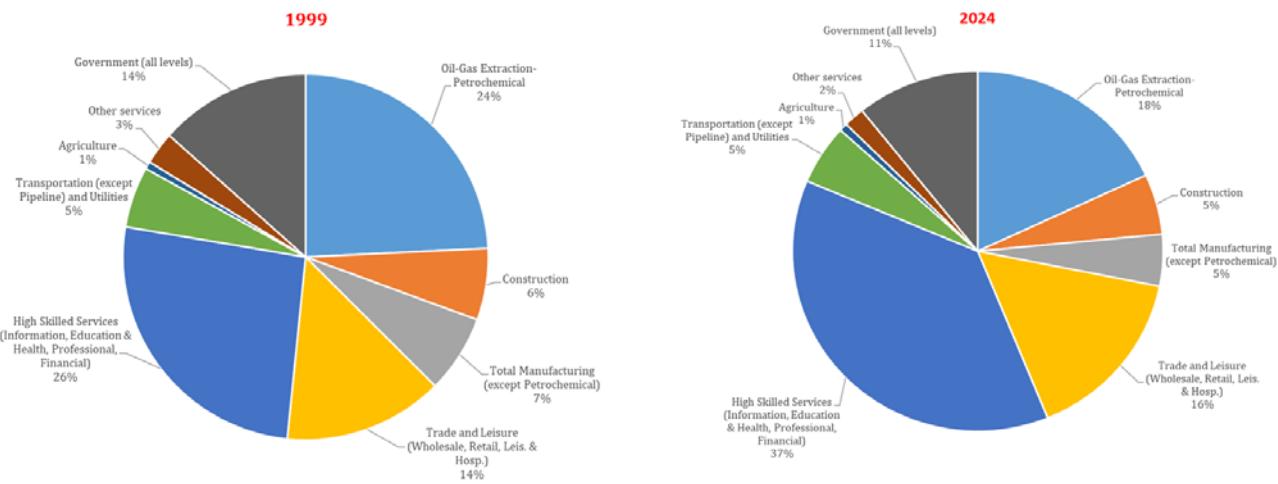

Louisiana Real Gross Domestic Product (GDP) (as measured in constant 2017 dollars) reached \$257.1 billion in 2024, which is a significant increase in real terms from the previous year (3.3%). This increase comes on the heels of a growth rate of 3.7% for the year 2023.

The biggest contributors to the growth rate in 2024 were the Construction, Manufacturing and Retail Trade sectors. After a small slump in 2023, the Construction sector rebounded, with a strong increase of 11.2%. In Manufacturing, the Non-durable Goods subsector (this is the area that produces foods, textiles and petrochemicals) stands out, with a growth rate of 11.9%. The Retail sector showed an expansion of 8.9%.



Louisiana Gross Domestic Product Composition



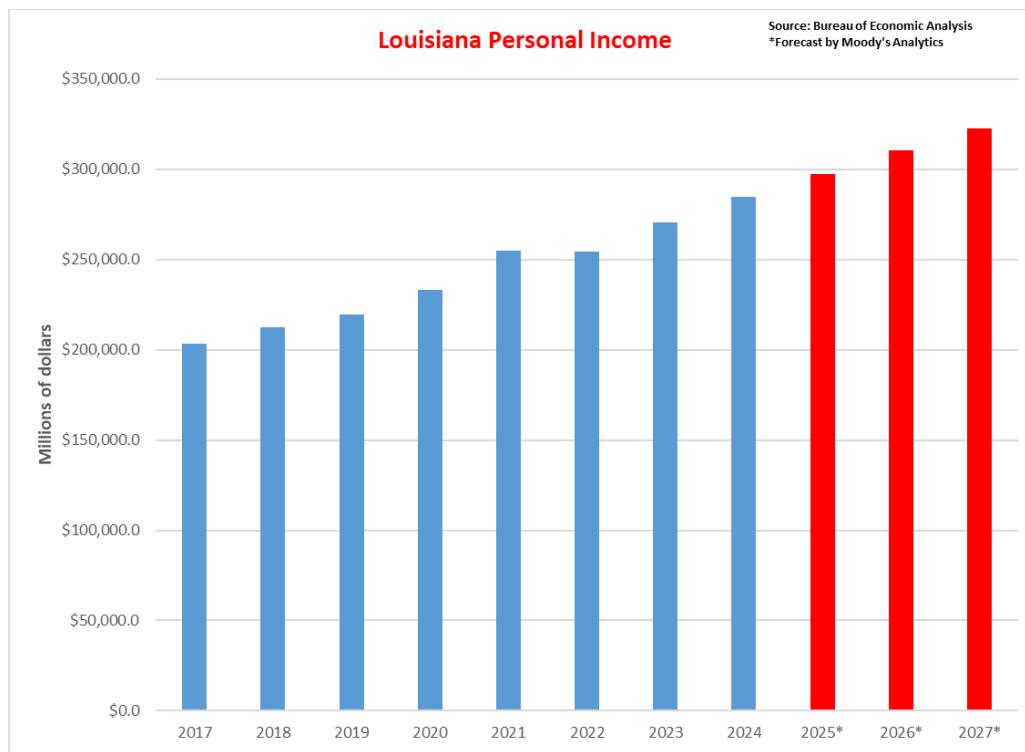
The above pie charts show the evolution of Louisiana Real Gross Domestic Product (GDP) over the span of about twenty-five years. The detailed data on Louisiana GDP for 2025 are not available at the time of this publication. What stands out is the contraction of the Oil/Gas/Petrochemical sector. In 1999, this sector covered about one-fourth of Louisiana's Gross Domestic Product. In 2024, the last full year of data available, this share represents less than one-fifth. The sector with the most expansion is the "high skilled" sector – encompassing Education & Health, Professional Services, Information, and the Financial sectors. In 1999 the share of this super-sector was about 26% of GDP compared to 37% in 2024. The Trade & Leisure super-sector (Wholesale and Retail Trade, and Leisure & Hospitality sectors) also expanded, from 14% to 16% of overall GDP.

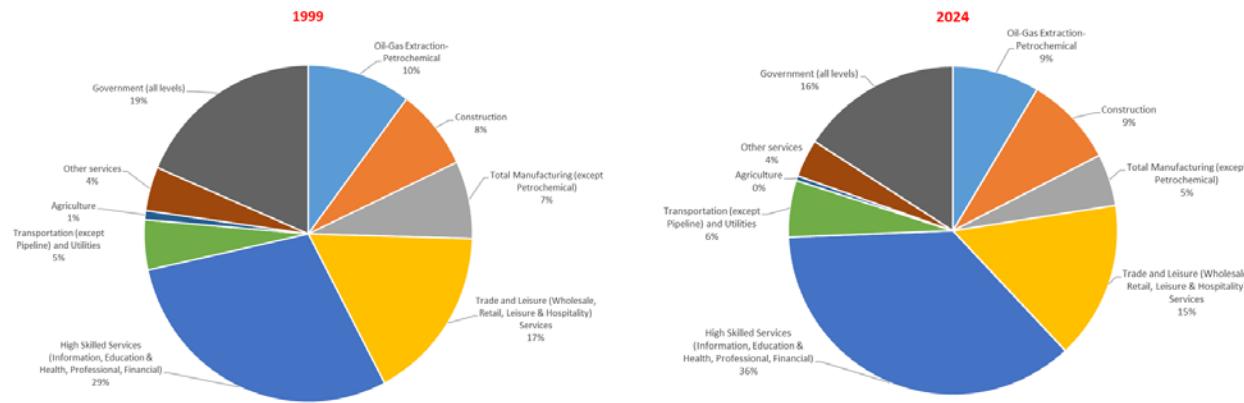

The latest data on Louisiana Personal Income (current dollars) show that it increased by 5.1% over calendar year 2024. (Data for calendar year 2025 are not currently available.) This follows an expansion of 6.4% in the previous year. Moody's Analytics projects a continuation of this performance, with increases of 4.5% in 2025, 4.4% in 2026 and 4% in 2027.





Louisiana Personal Income Composition



In 1999, the Oil/Gas/Petrochemical sector covered a share of about 10% of Personal Income as compared to 9% in 2024. Detailed data for 2025 are not available at the time of this publication. The "high skilled" super-sector (Education & Health, Professional, Information and Financial) expanded from 29% to 36%. The Government sector (at all levels) reduced its share by 3 percentage points, from 19% to 16%.

Over the last three years, US real GDP has been growing at respectable rates, 2.5% in 2022, 2.9% in 2023 and 2.8% in 2024. Moody's Analytics forecasts a slowdown in these growth rates. For the next three years, the projection is that they will waver around 2%.



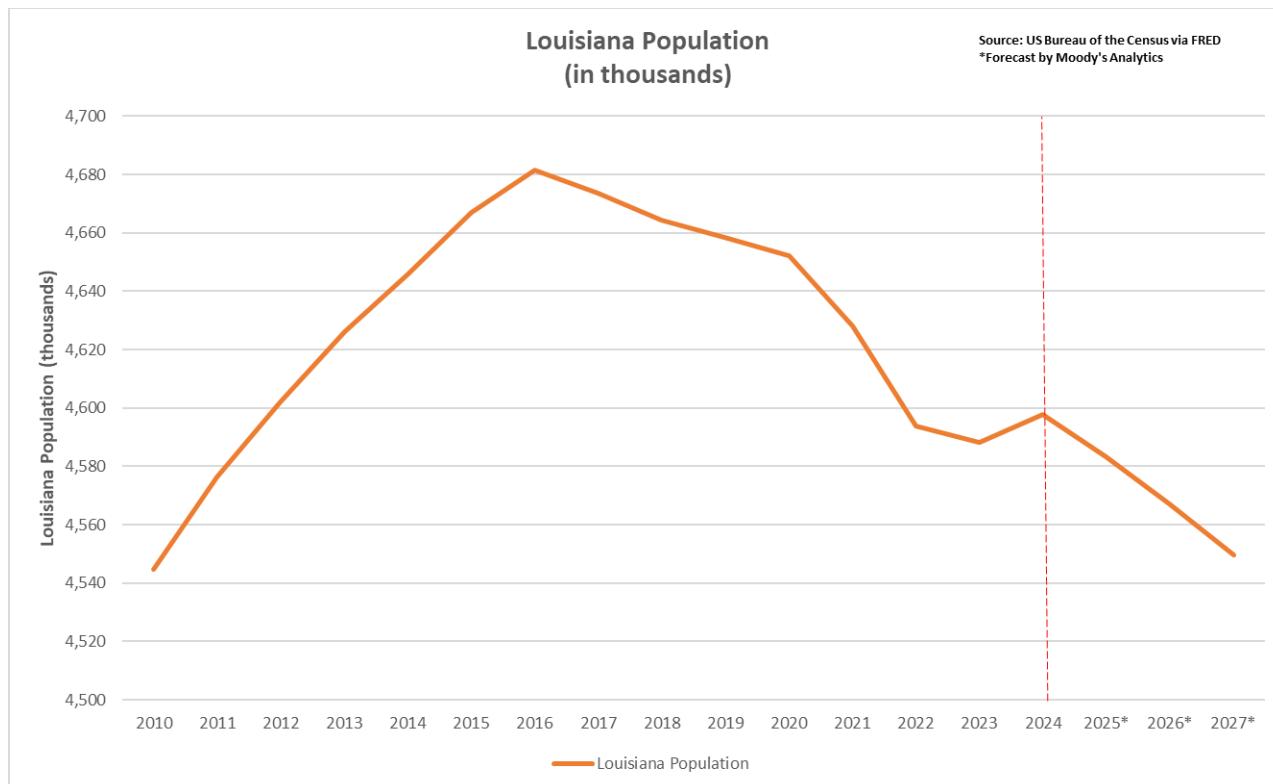

Louisiana population had been increasing steadily in the years after Hurricane Katrina, reaching a peak of almost 4.7 million in 2016. In the years after, it started to decrease on average between 0.2% and 0.3% per year. The latest data available from the US Bureau of the Census (as of July 1, 2024) reports the total state population at right under 4.6 million. Moody's Analytics forecasts small population decreases for the following three years.



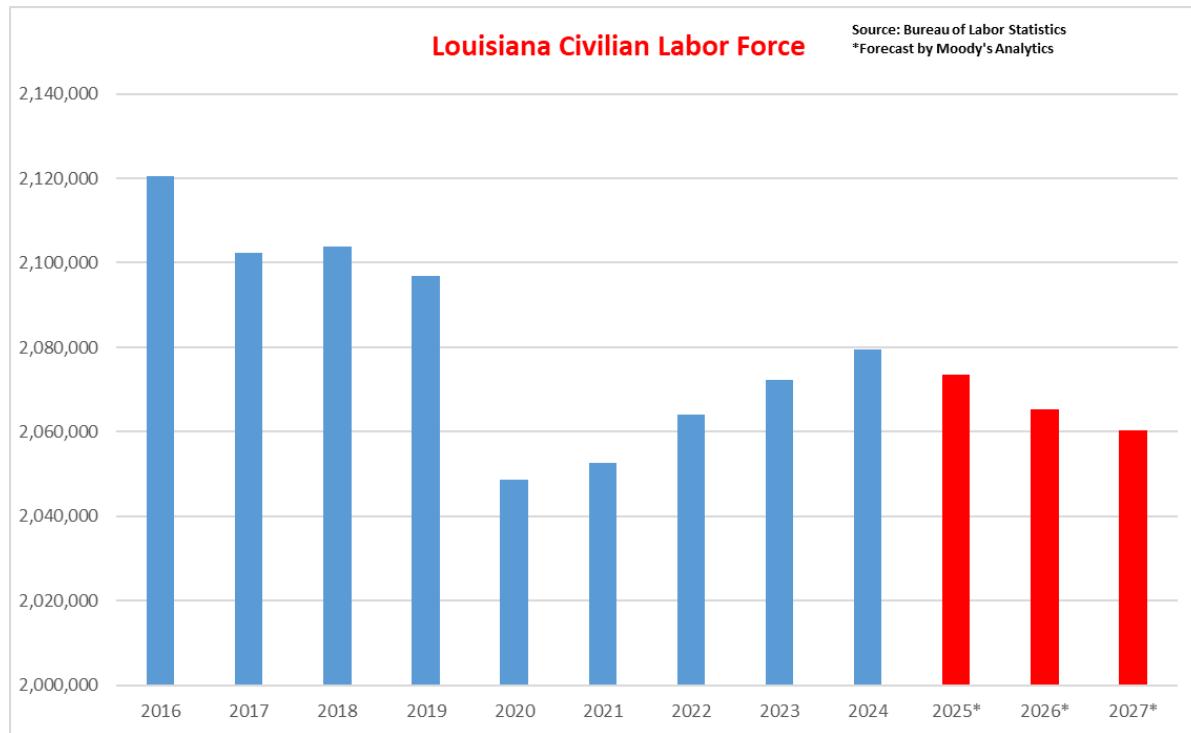

The labor force includes all people aged 16 and older who are classified as either employed or

unemployed. Conceptually, the labor force level is the number of people who are either working or actively looking for work. In the years after Hurricane Katrina, the labor force in Louisiana hovered around 2.1 million people. It reached a peak in 2015, with 2.16 million, and in the years since, it returned to its norm of 2.1 million. The global 2020 pandemic caused the labor force to fall to about 2.06 million. The last year of full data, 2024, the labor force increased to almost 2.08 million. Moody's Analytics forecasts small reductions over the next three years.



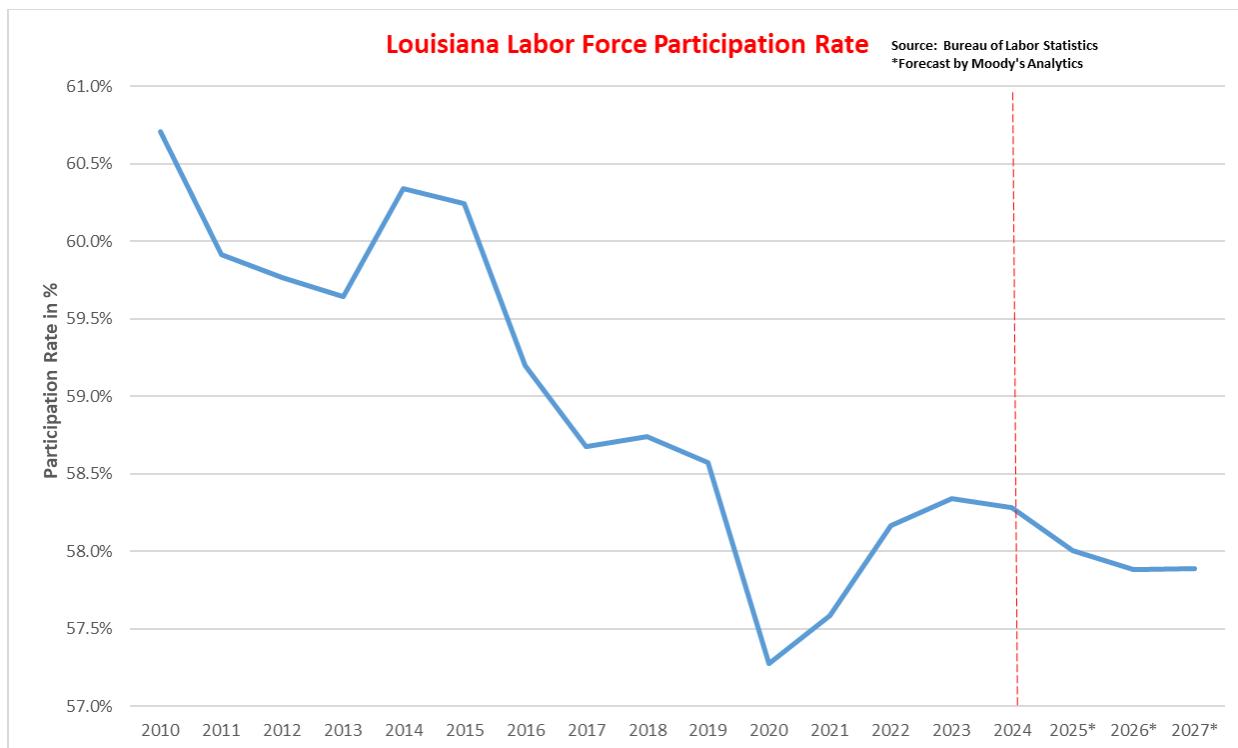

The labor force participation rate represents the number of people in the labor force as a percentage of the civilian non-institutional population. [The civilian non-institutional population age 16 and older is the base population group considered by the Bureau of Labor Statistics. It excludes people in the Armed Forces, people in jail and in residential care facilities.]

The labor force participation rate in Louisiana has been decreasing gradually in the decade of the 2010s (with a brief exception in the middle of the decade). In the year before the pandemic, 2019, it reached a low of 58.6% and the pandemic caused a further decline. In 2022 and 2023, it recovered to some extent to 58.2% and 58.3% respectively, holding steady at 58.3% in 2024. Moody's Analytics forecasts slight decreases for the next three years.

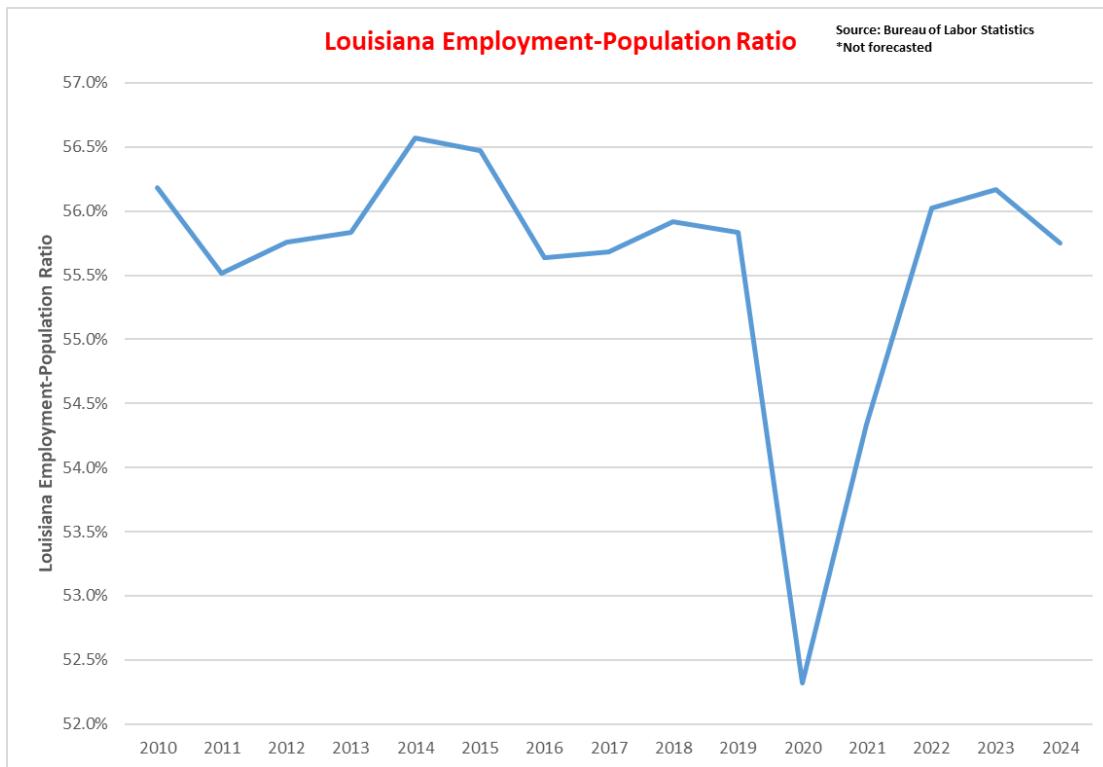

The employment-population ratio represents the number of employed people as a percentage of the civilian non-institutional population. In other words, it is the percentage of the population that is currently working. The employment-population ratio, because it is unaffected by voluntary changes in labor force participation, is a useful indicator of current labor market conditions. For Louisiana, it hovered around 56% for most of the 2010 decade until the global pandemic hit. In 2020, it fell to a low of 52.3%, but recovered, and attained its normal level of 56% by 2022. Moody's Analytics does not forecast this statistic.

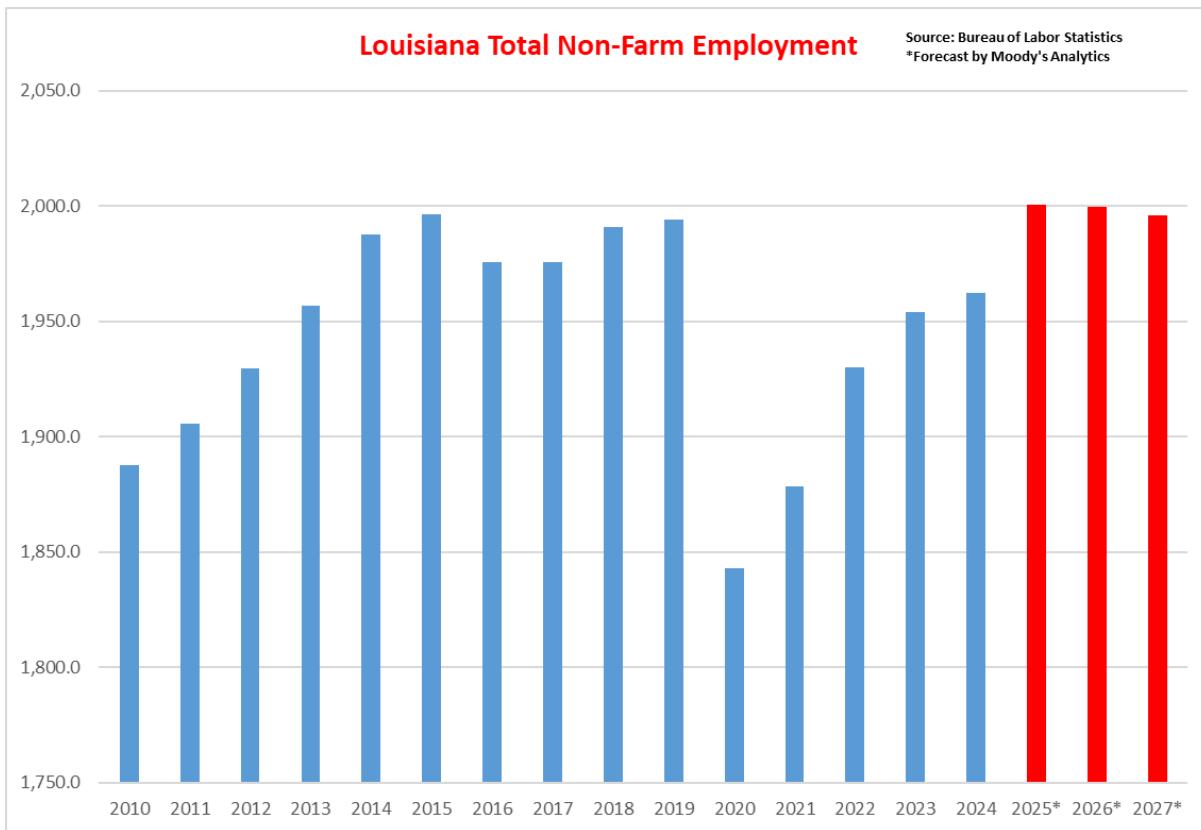

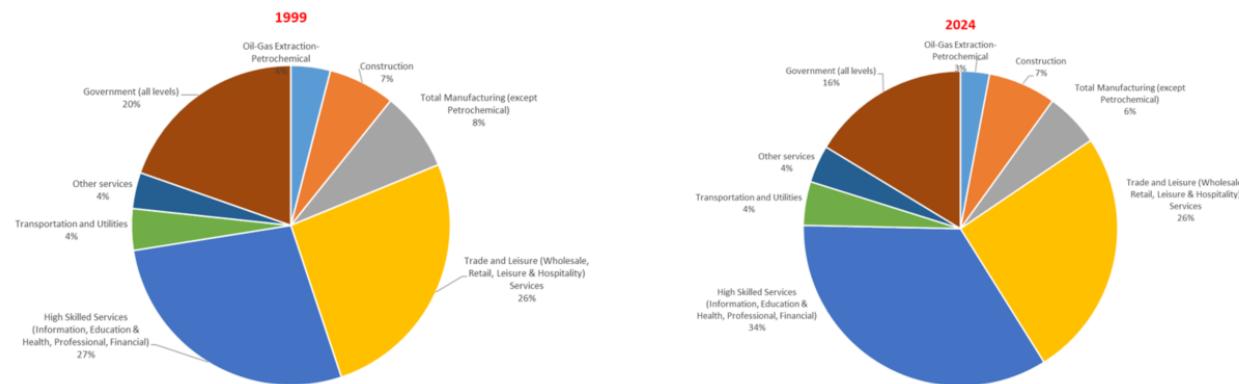

Louisiana total non-farm employment evolved in a positive way over the last three years – slowly but steadily reaching the two million mark in May 2025. The largest contributor to the recovery after the pandemic is the Education & Health Supersector, with 41,000 jobs created since the peak of February 2019. Moody's Analytics projects a small slowdown in job creation – but this is partially conditioned by the fact that job creation is bumping against the size of the labor force in our state.





Louisiana Employment Composition



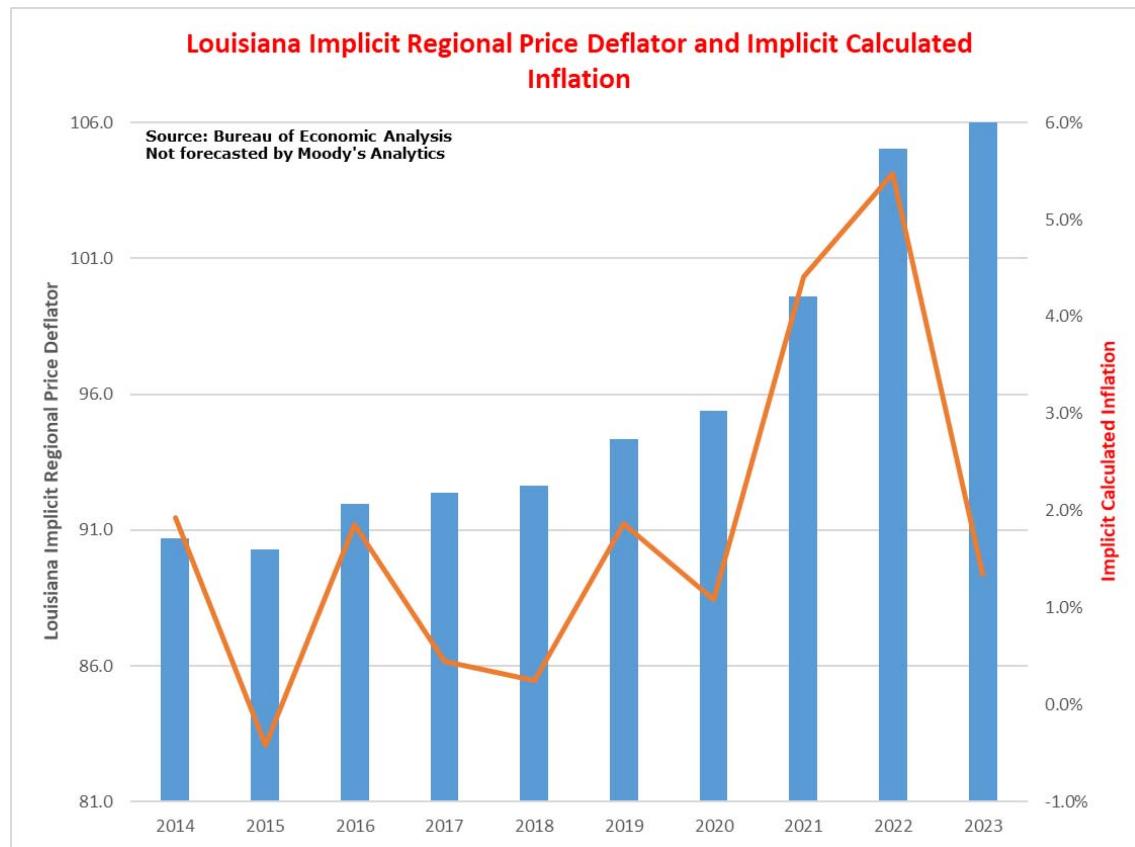
Over the last twenty-plus years Louisiana employment gradually shifted toward a service oriented economy. Trade & Leisure and the High Skilled sectors represented about 53% of employment in 1999. By 2024, these two super sectors represented 60%, with the High Skilled sector expanding its stake. Government employment (at all levels) shrank by 4% (from 20% to 16%) and Total Manufacturing (except Petrochemical) also reduced its share from 8% to 6%.

Prices

Implicit Regional Price Deflator

There are no good price index statistics for states. Most of the price indices provided by the federal government are calculated nationwide only. However, the Bureau of Economic Analysis provides a regional (state) price index. This index, the Implicit Regional Price Deflator, is computed for each state. The growth rate, or year-to-year change in the Implicit Regional Price Deflator, is a measure of regional inflation. The Price Deflator is provided once a year in December. Unfortunately, because of the federal government shutdown during October and early November 2025, the data for calendar year 2024 have not been released.

The chart on the following page shows the Price Deflator level and growth rate for the state of Louisiana. According to this measure, inflation was between 1% and 2% in the previous decade, but in 2022, it increased to 5.5%. This is consistent with the fact that, in that year, the US inflation rate accelerated significantly, as shown below. In 2023 the rate of change in the deflator returned to more normal levels, 1.3%.

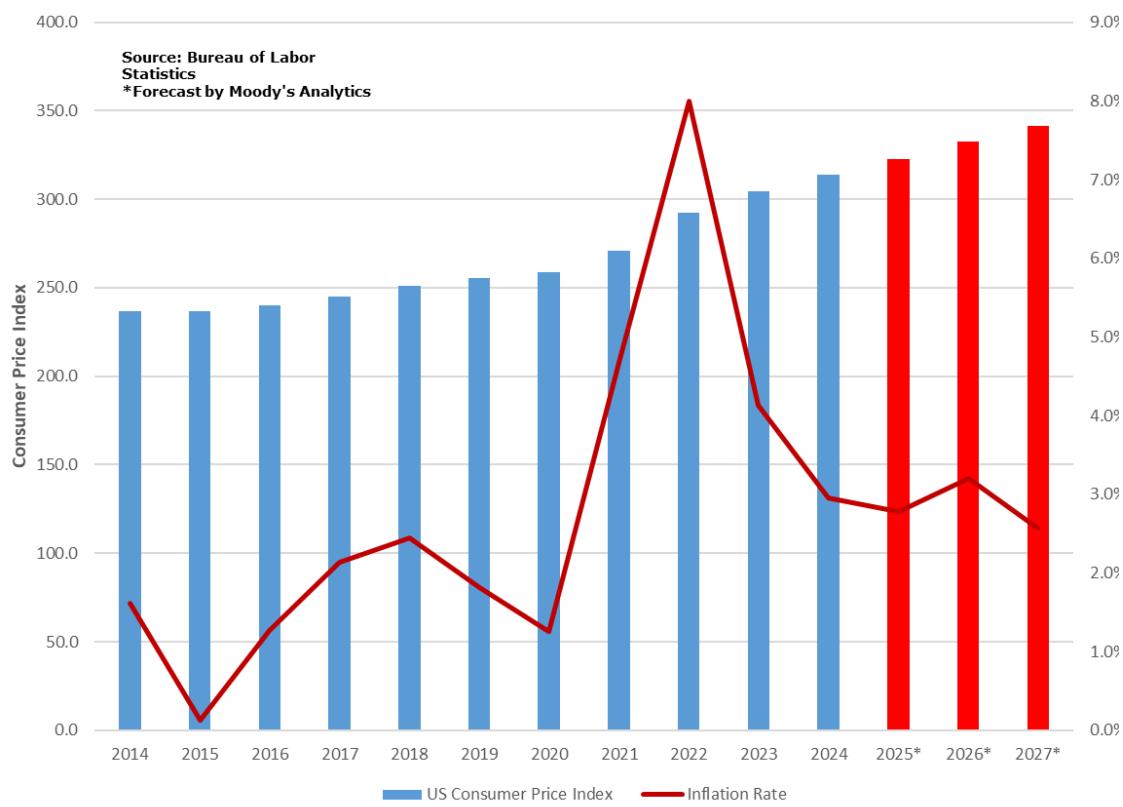

One index that is widely followed to measure inflation is the US Consumer Price Index for all urban areas, produced by the Bureau of Labor Statistics. The inflation rate (changes in the index) fluctuated between 1% and 2% throughout the 2010 decade. In 2020, the inflation rate was 1.3%. The following year, 2021, it increased notably to 4.7%, almost doubling to 8% in 2022. The following year, as a consequence of the tightening of monetary policy by the Federal Reserve, inflation moderated a bit to 4.1%. In 2024 inflation fell a bit further to 3.0%. Moody's Analytics estimates inflation will be 2.8%, 3.2% and 2.6% in the following three years.

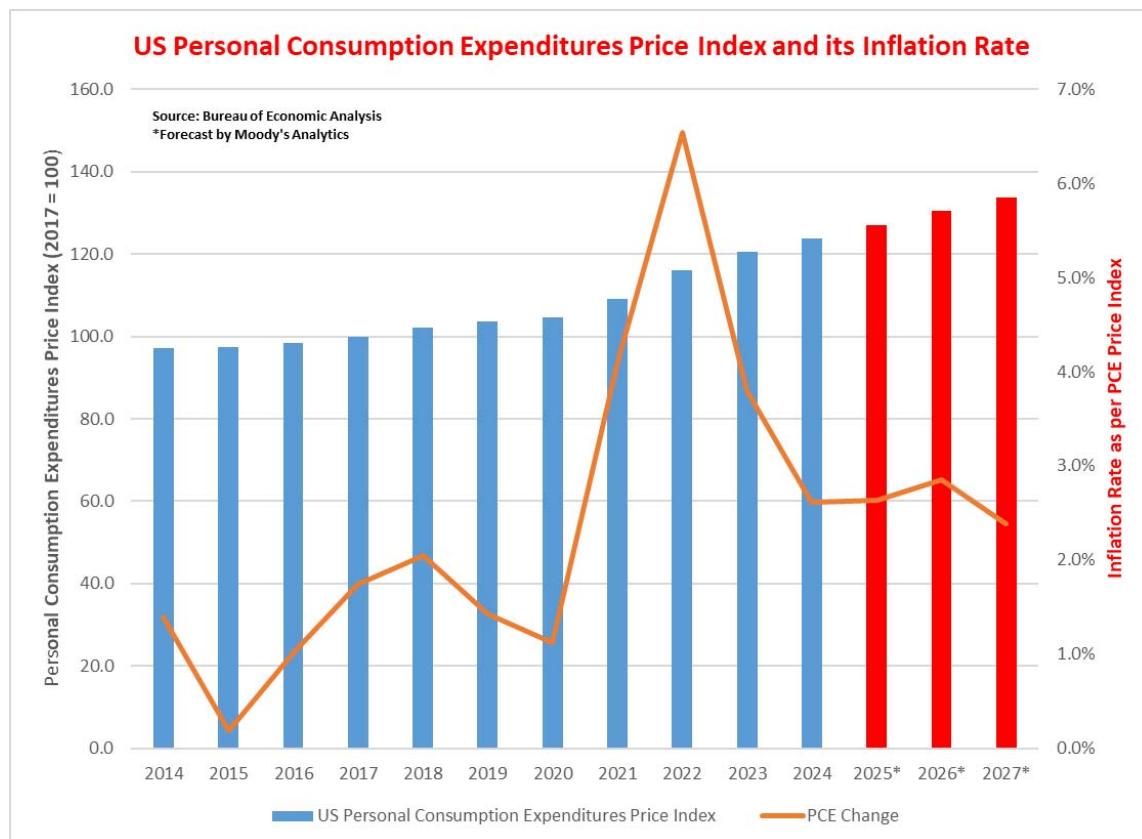

Another extensively used measure of the inflation rate is the change in the US Personal Consumption Expenditures Price Index (PCE Index), as calculated by the Bureau of Economic Analysis. This is the preferred measure of the Federal Reserve to implement its monetary policy. The PCE Index is a broader measure of inflation since it encompasses many more goods and services than the Consumer Price Index (and it is also calculated differently as the CPI).

Similarly to the Consumer Price Index, the PCE Index rate of change hovered around 1% and 2% for most of the last decade. In 2021, it increased to 4.1% and the following year it increased even further to 6.5%. The last year of available data is 2024, where the PCE Index receded to 2.6%. Moody's Analytics forecasts that the inflation rate based on this index, will be 2.6% in 2025, 2.9% in 2026 and 2.4% in 2027.



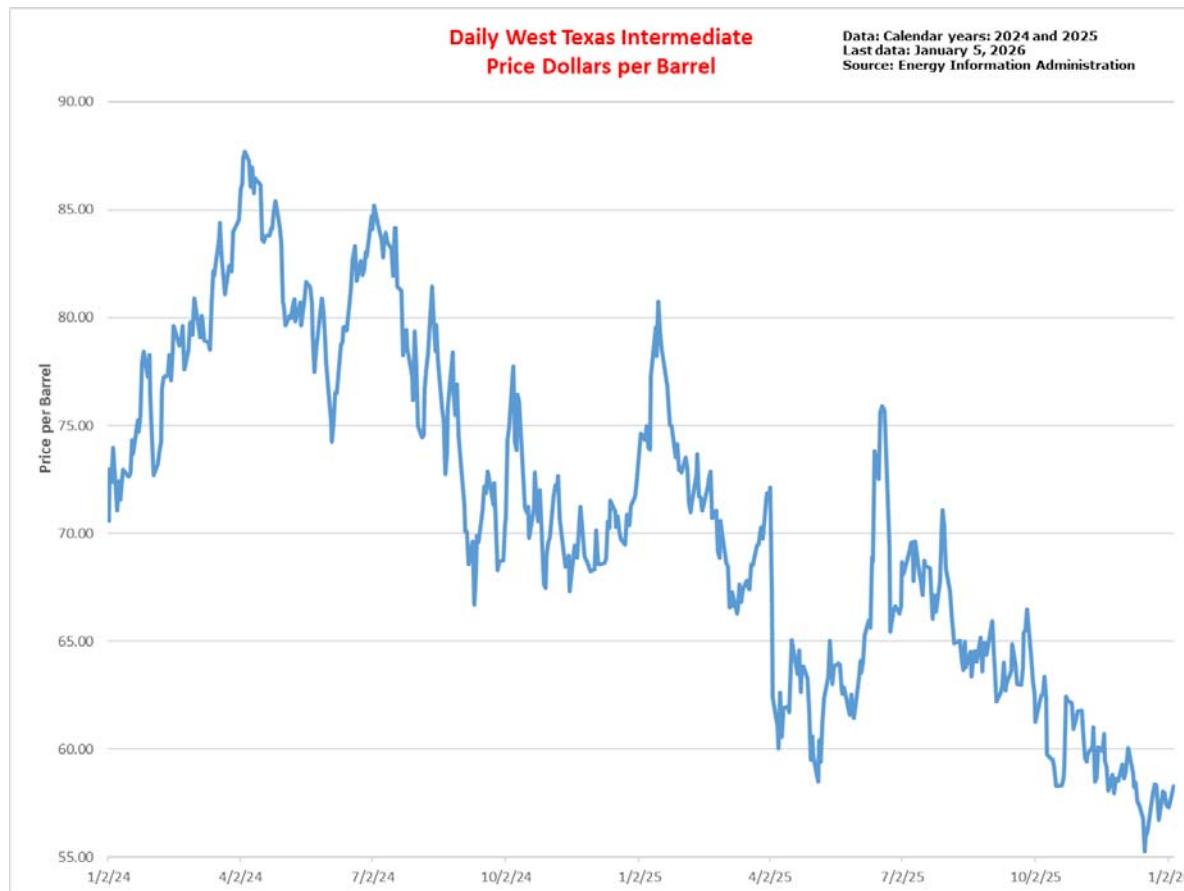

Crude oil prices continue to be an important focal point for policymakers in Louisiana. This is the reason why the Revenue Estimating Conference (REC) adopts a projection of the oil price every time it revises the forecast.

The box above shows the fiscal year annual average of the West Texas Intermediate crude oil type, dollars per barrel. After reaching heights of almost \$90 per barrel in the early months of 2024, the price of crude oil has been steadily falling (with some variance). The daily annual average for FY 2023-2024 reached \$82.15 but fell by \$10 at the time FY 2024-2025 came to a close to \$72.60. Reasons for this decrease include the fact that major suppliers of crude oil increased production and various policy changes are impacting domestic oil extraction.

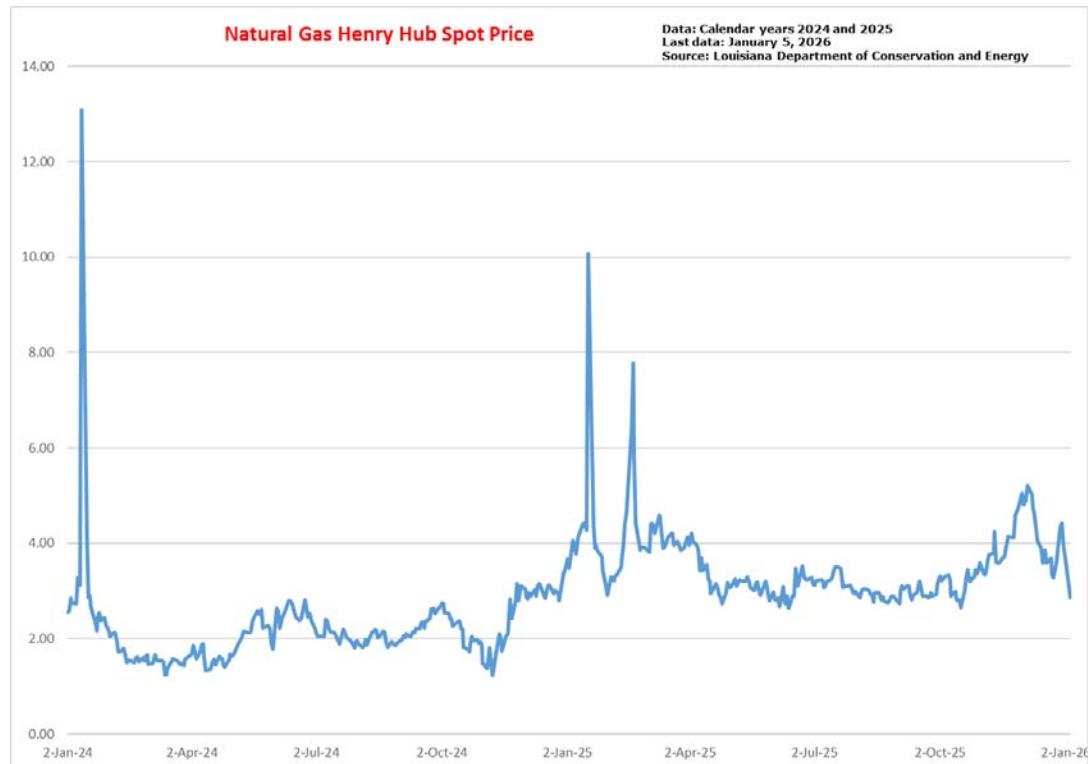
The latest Revenue Estimating Conference of December 11, 2025 adopted a forecast for the crude oil price for the ensuing fiscal year FY 2025-2026 of \$59.76 and for the following fiscal year FY 2026-2027 of \$59.95.

Another important price for Louisiana is the natural gas price, usually measured by the Henry Hub Spot price. A forecast for this price is also adopted by the Revenue Estimating Conference, which is why the box above shows annual averages by fiscal year. Throughout the 2010 decade, this price fluctuated around \$2 per million British Thermal Units (mmBTU), but with the war in Ukraine and the threat of Russia to cut off natural gas supplies to Europe, this price increased significantly during 2022. During FY 2023-24, the average price decreased to \$2.19, rising to \$3.13 in the fiscal year that just closed. The REC adopted a forecast of \$3.70 for FY 2025-2026 and \$4.37 for FY 2026-2027.

Revenue Summary

Fiscal Year 2024 – 2025

FY 2024-2025 saw a decrease in revenue collections as measured by Taxes, Licenses & Fees (TLF), compared to FY 2023-2024. This broad measure tracked by the Revenue Estimating Conference (REC) decreased by 1.9%. In addition, Statutory Dedications fell by 6.1% compared to the previous fiscal year. The State General Fund (SGF) collection declined by 0.4%.

Fiscal Year 2025 – 2026

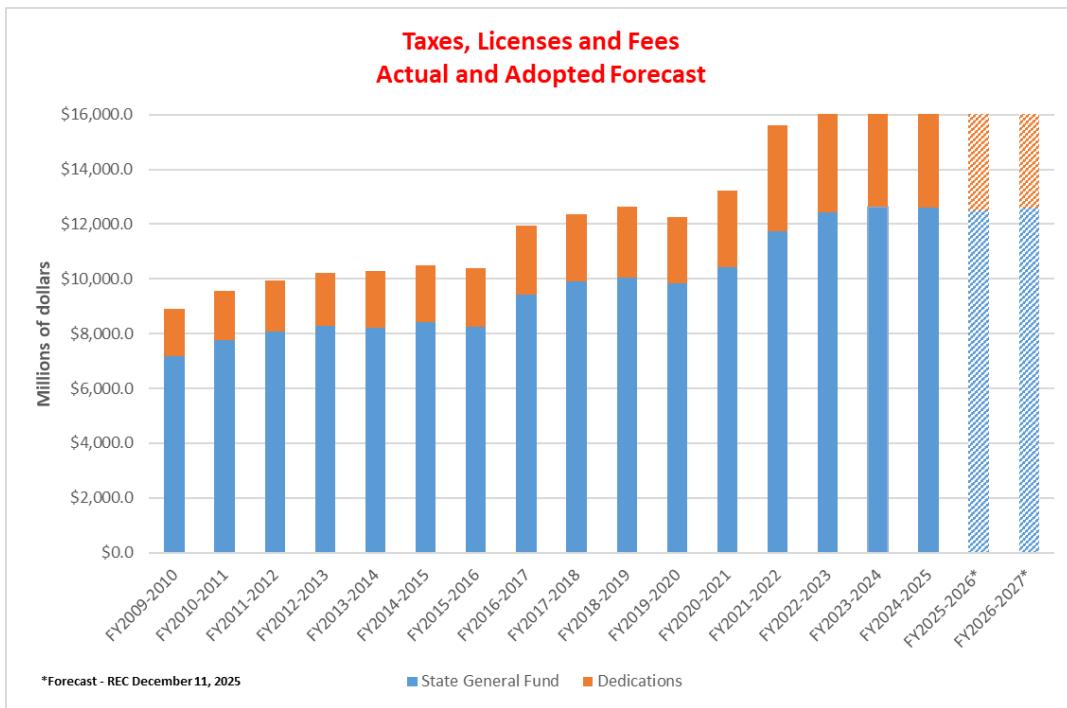
The Revenue Estimating Conference (REC) met December 11, 2025 and adopted a forecast for Taxes, Licenses & Fees for FY 2025-2026 (current fiscal year) that is about \$753 million lower than the actual collections in FY 2024-2025. The State General Fund is forecast to decrease by \$86.4 million, compared to the actual collection in FY 2024-2025. In November 2024 the legislature met to pass an overhaul of the major revenue streams supporting TLF. These tax code changes affected principally the Individual Income Tax, the General Sales Tax (and its companion Motor Vehicle Sales Tax) and the Corporate Income & Franchise Taxes. On the Individual Income Tax side, personal exemptions were increased significantly and the higher income tax rates were reduced to a flat rate of 3%. The Sales Taxes were increased to 5% (for a period of five calendar years) and the tax base was broadened to include some digital services. On the Corporate Collections side, the brackets of corporate income tax rates were eliminated and a flat 5.5% was introduced, and some tax credits and exemptions were eliminated.

After almost one year of these changes, the overhaul is working as intended. Overall, the Individual Income Tax collection has been falling and the General Sales taxes have been increasing, both effects as expected. This will be seen below when some of the revenue streams are discussed.

Fiscal Year 2026 – 2027

The REC on December 11, 2025 also revised the forecast for FY 2026-2027 (the ensuing fiscal year). It projects that, compared to current fiscal year, TLF will see a small reduction of almost \$18 million and the State General Fund an increase of \$109.2 million (this increase in SGF is due to the Statutory Dedications falling by more than TLF).

The following chart shows the evolution of Taxes, Licenses & Fees including the latest REC projections.



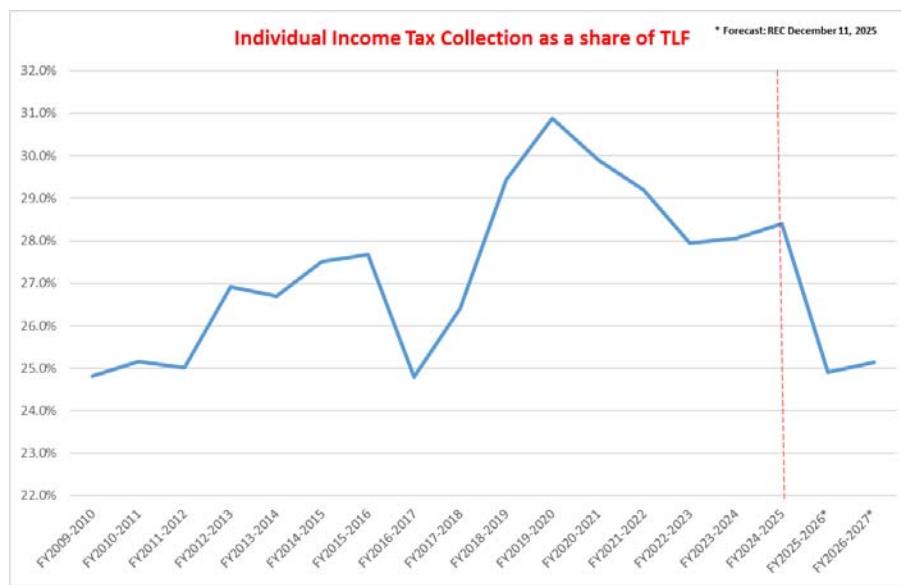
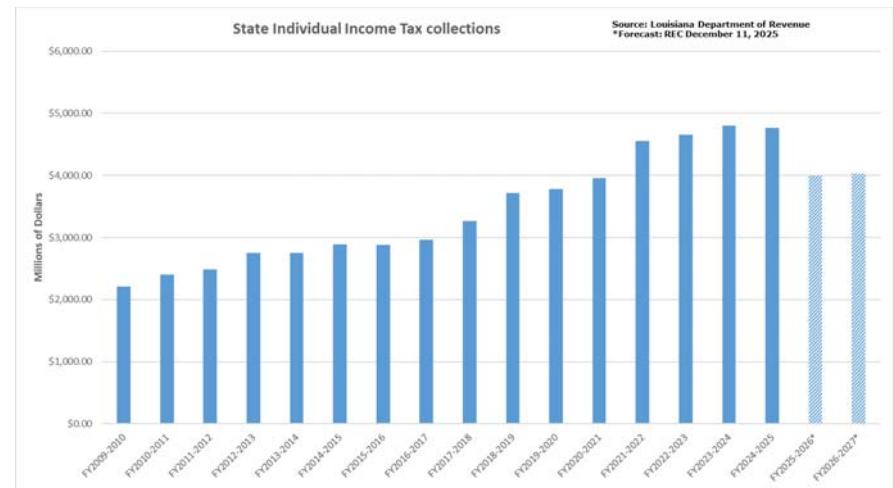

The Individual Income Tax historically represented between 25% and 30% of the total collection of Taxes, Licenses and Fees. However, this percentage may decrease to some extent given the tax reform discussed above. It has no significant dedications, which means it supports the State General Fund in a sizable share as well. The collection of this tax has consistently increased in recent years. Projections for FY 2025-2026 and FY 2026-2027 show a projected decrease in collections. This decline is due to the tax reform discussed in the beginning of the Revenue section.

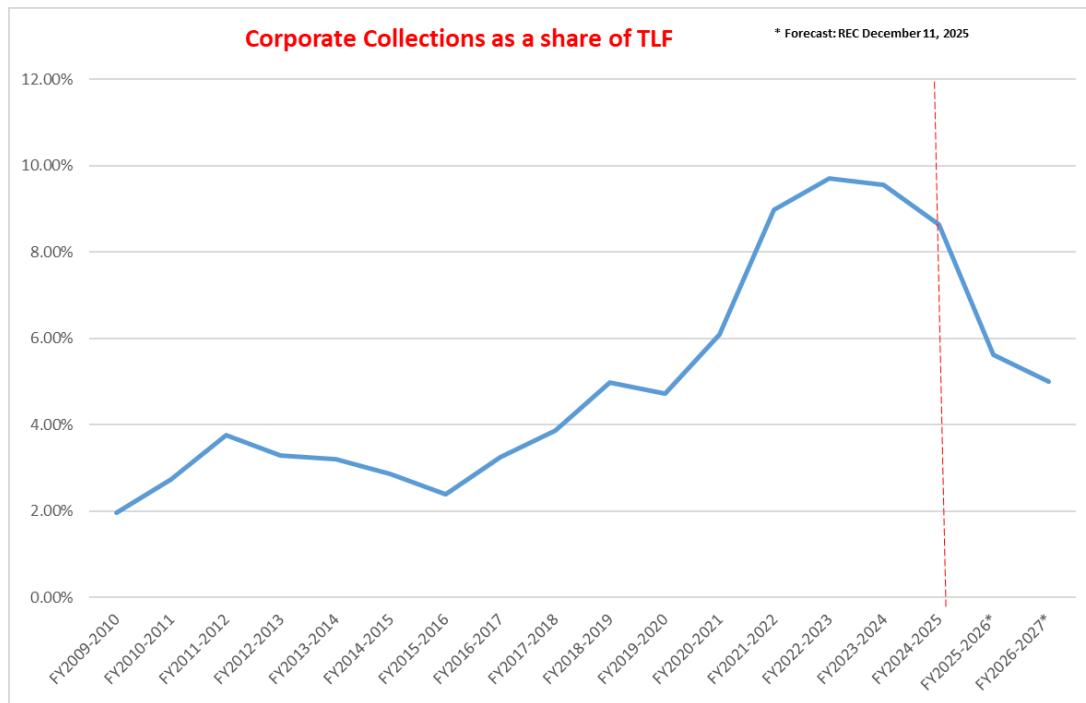
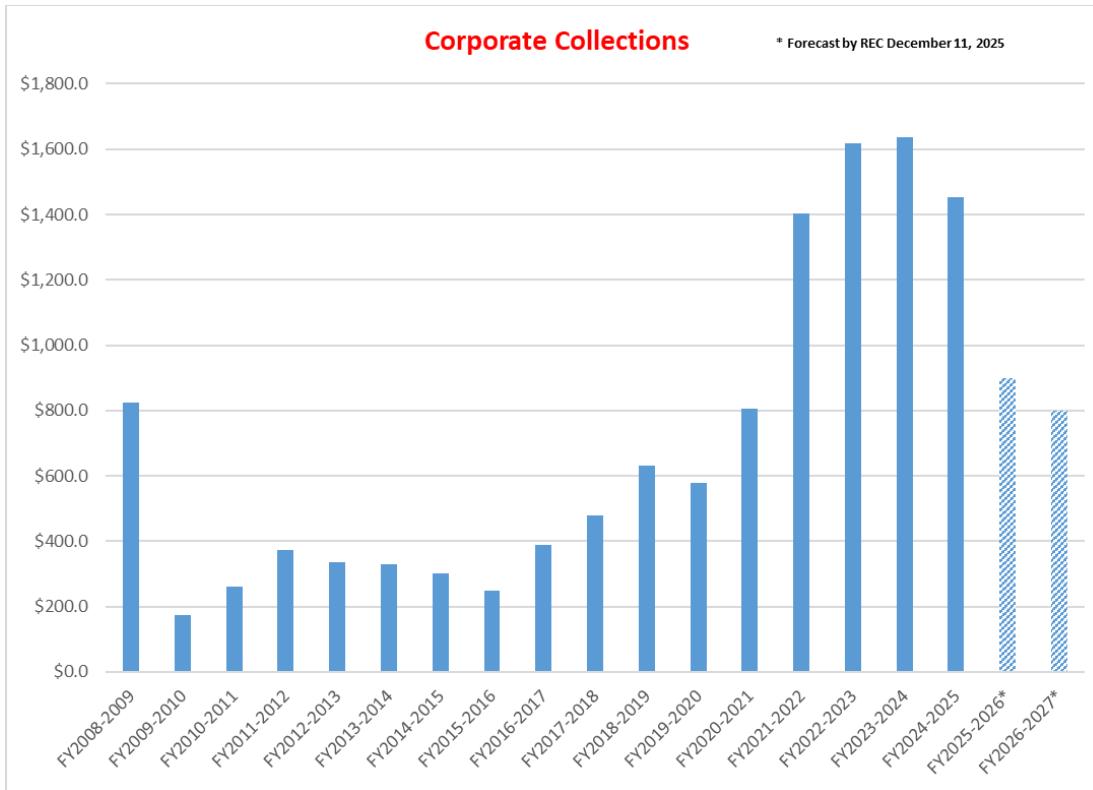

Corporate collections have historically been comprised of revenues from the Corporate Income Tax and the Corporate Franchise Tax. Out of the total, around 75% come from the Income Tax and the rest from the Franchise Tax. The tax reform from November 2024 will significantly change the future composition and collection of corporate collections. The reform introduced a flat corporate income tax of 5.5% and changes to exemptions and the treatment of credits and deductions. In addition, the corporate franchise tax is eliminated starting tax year 2026. Corporate collections above \$600 million flow into the Revenue Stabilization Trust Fund (RSTF). The projections of the Revenue Estimating Conference reflect the changes in the tax code.

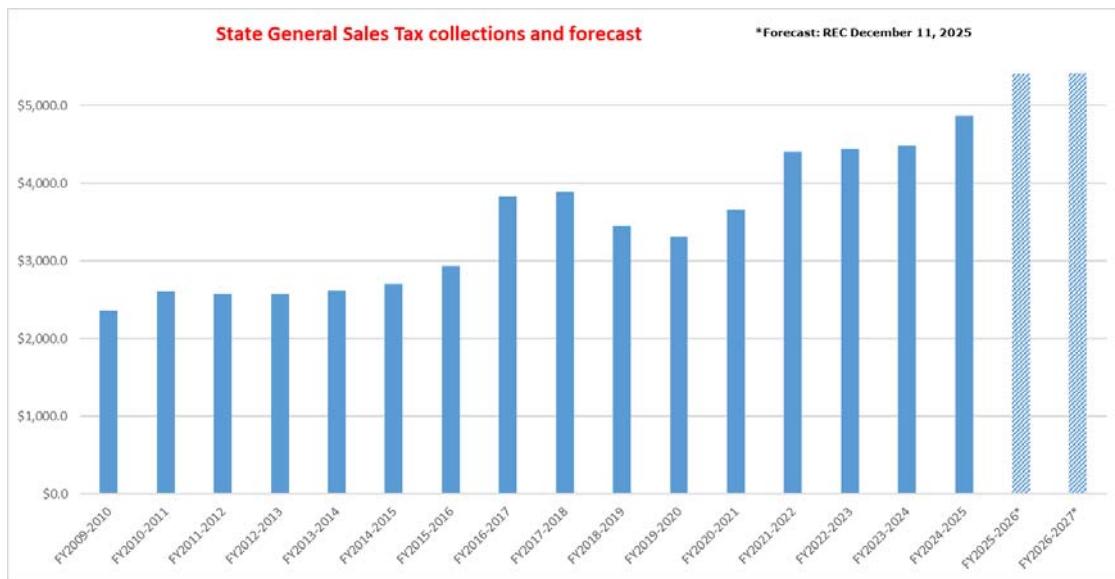


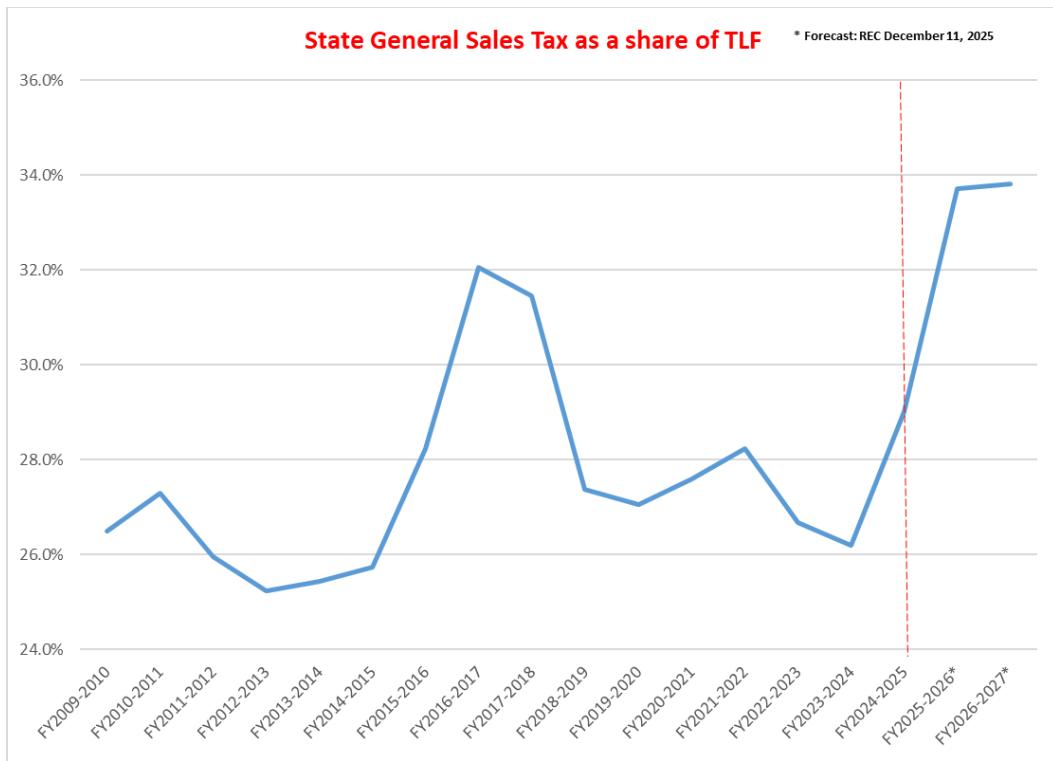
General Sales Tax

Another important revenue stream sustaining TLF is the General Sales Tax. Its share of TLF fluctuated in recent years between 24% and 28%. The collection of this tax has generally been increasing in recent years, but it was affected by rate changes enacted by the Legislature. For example, Act 62 of the 2016 First Extraordinary Session increased the state sales tax rate from 4% to 5% (April 1, 2016 through June 30, 2018). Thus, this rate increase encompassed the last few months of FY 2015-2016 through FY 2017-2018. When the 1% sales tax rate expired, the legislature voted to keep an increase in the rate of 0.45%. This reduction in the rate can be seen in the collections for FY 2018-2019 and FY 2019-2020. The increase in the following fiscal years was mostly driven by support from the federal government during the global pandemic.

The tax reform enacted by the Legislature in November 2024 increased the state sales tax rate from 4.45% to 5%, starting January 1, 2025 – for the period of five calendar years until December 31, 2029. The increase in the rate is reflected in the forecast for current and the ensuing fiscal years.

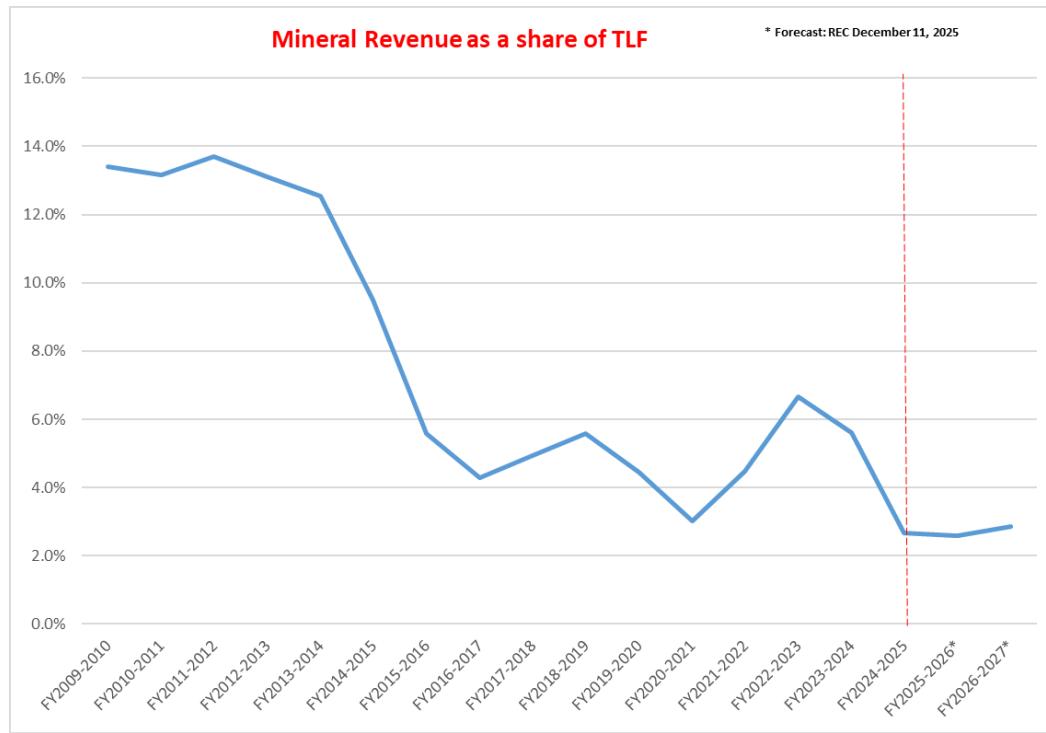
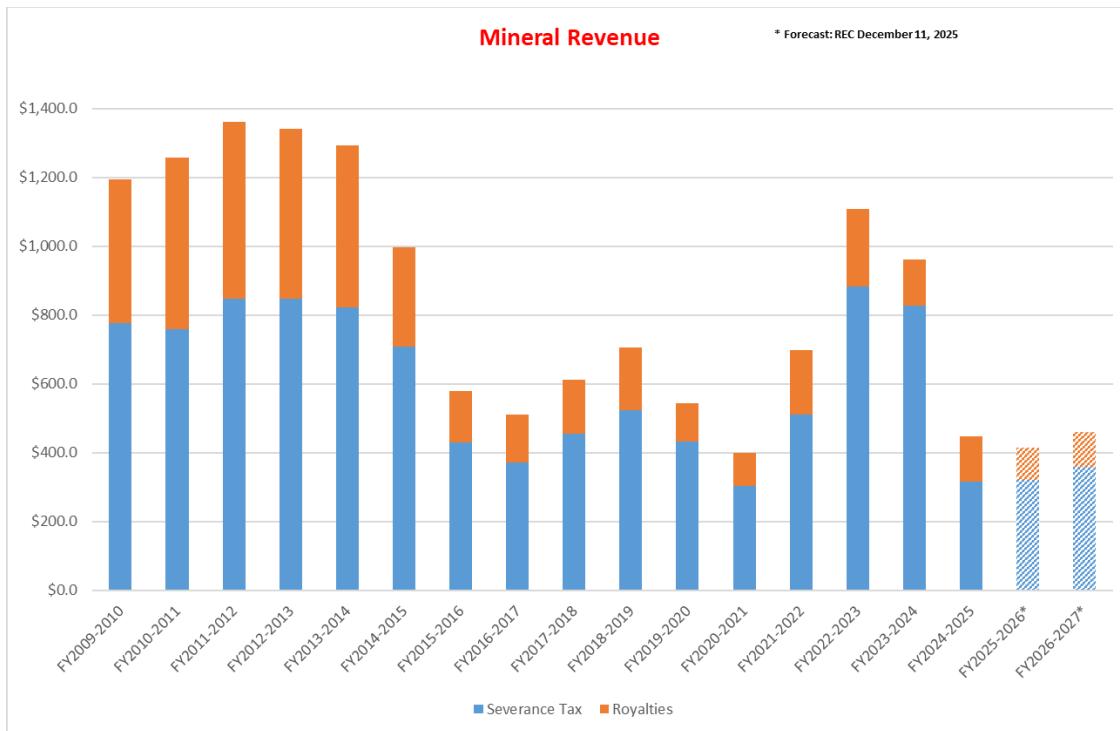

As a crude oil and natural gas producing state, mineral revenue from these two resources has traditionally been a focal point for state policymakers. Forty years ago, Mineral Revenue comprised over 40% of the tax base, but a lot has changed since then. By the late 2000s, the share of Mineral Revenue fell to right over 10%, and a few years later, it decreased further to about 5%. This decline was mostly due to the drop in the price of crude oil in 2015, but a low natural gas price also played a role. In addition, crude oil production in Louisiana fell significantly – in 2010 Louisiana was still producing over 60 million barrels of crude oil, but recently no more than 30 million barrels were extracted. Natural gas production had a big push when the Haynesville Shale was developed starting around 2007. However, much of this natural gas extraction was not subject to tax because of the horizontal drilling exemption. Should the collection of Mineral Revenue reach levels higher than \$660 million (after accounting for a couple of dedications of the Severance Tax and Royalty payments), the amount between \$660 million and \$950 million is dedicated to the Revenue Stabilization Trust Fund and the Unfunded Accrued Liability of some of the state pension systems.

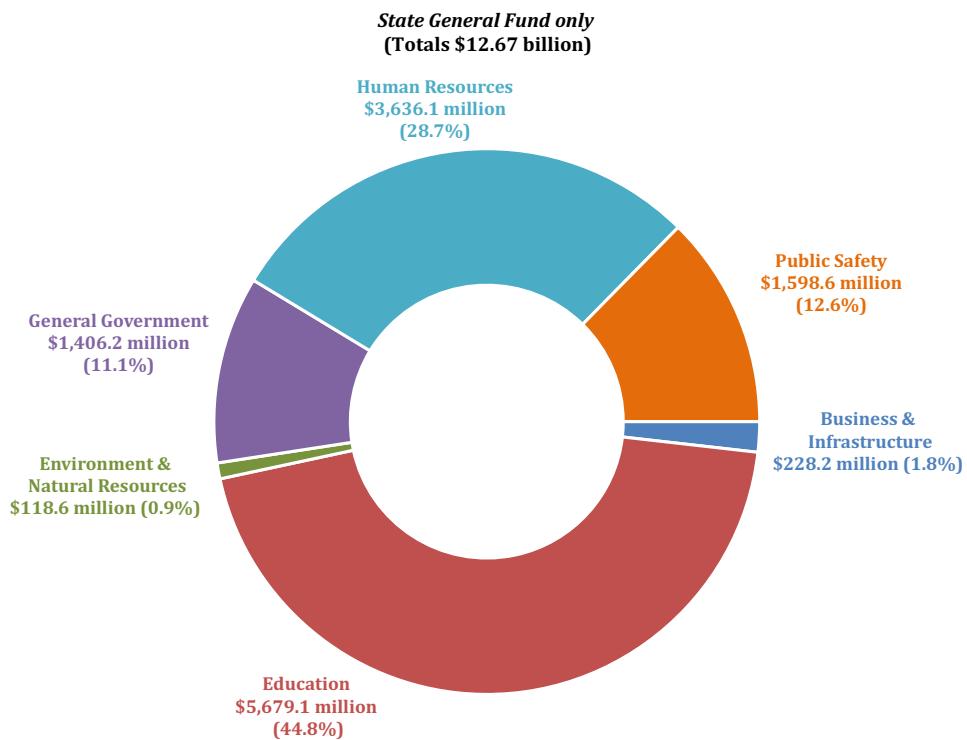

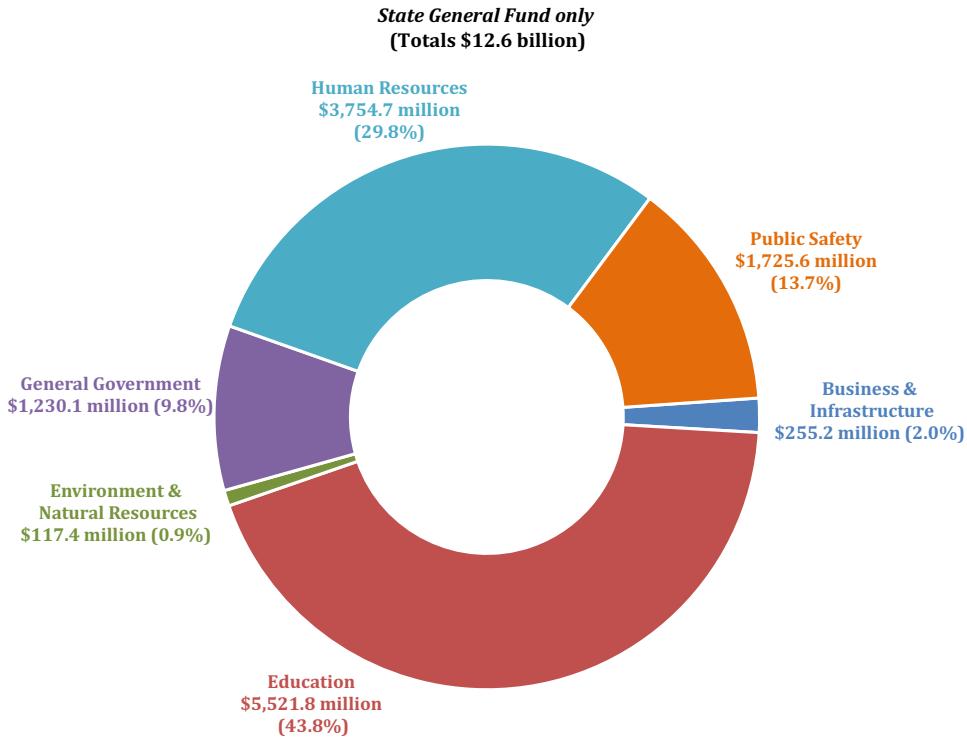

FY 2025-2026 EOB State General Fund Expenditures by Functional Area

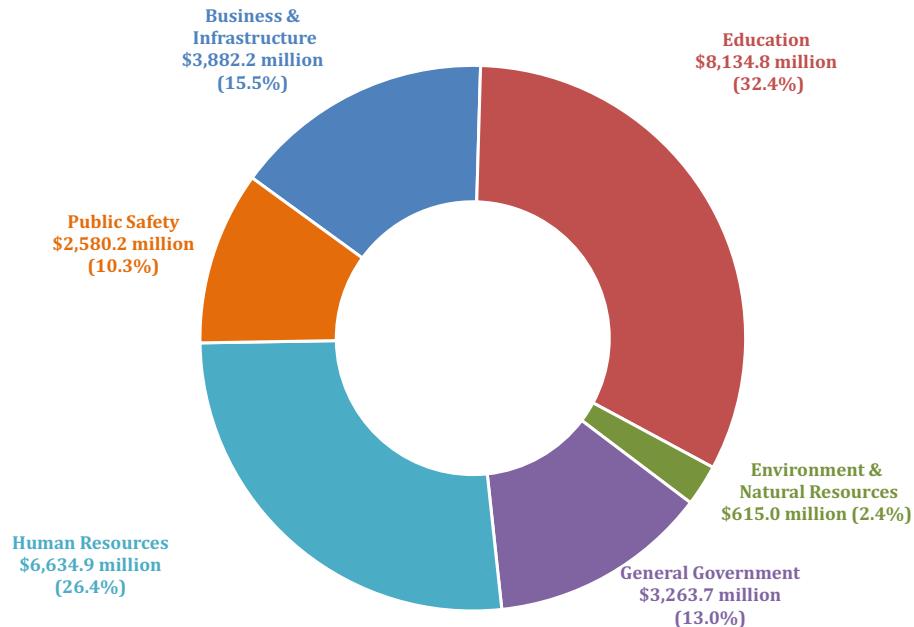


FY 2026-2027 Recommended State General Fund Expenditures by Functional Area



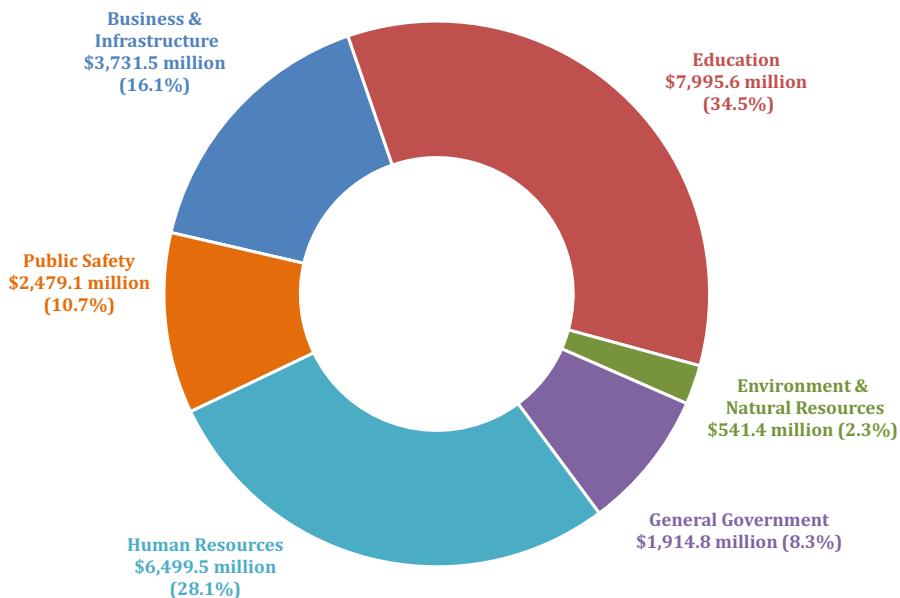
FY 2025-2026 EOB State Funded Expenditures by Functional Area

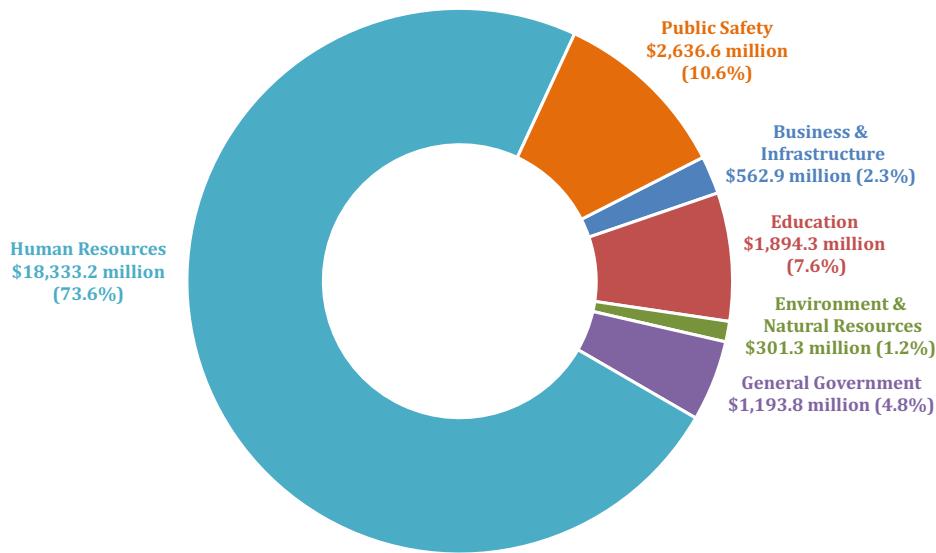
FY 2026-2027 Recommended State Funded Expenditures by Functional Area

 (Totals \$23.16 billion)



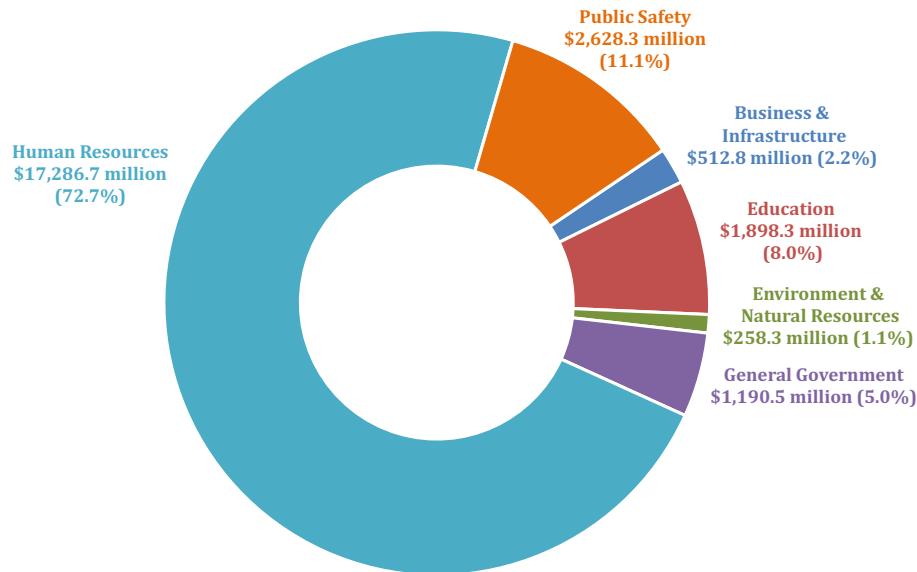
FY 2025-2026 EOB Federal Funded Expenditures by Functional Area

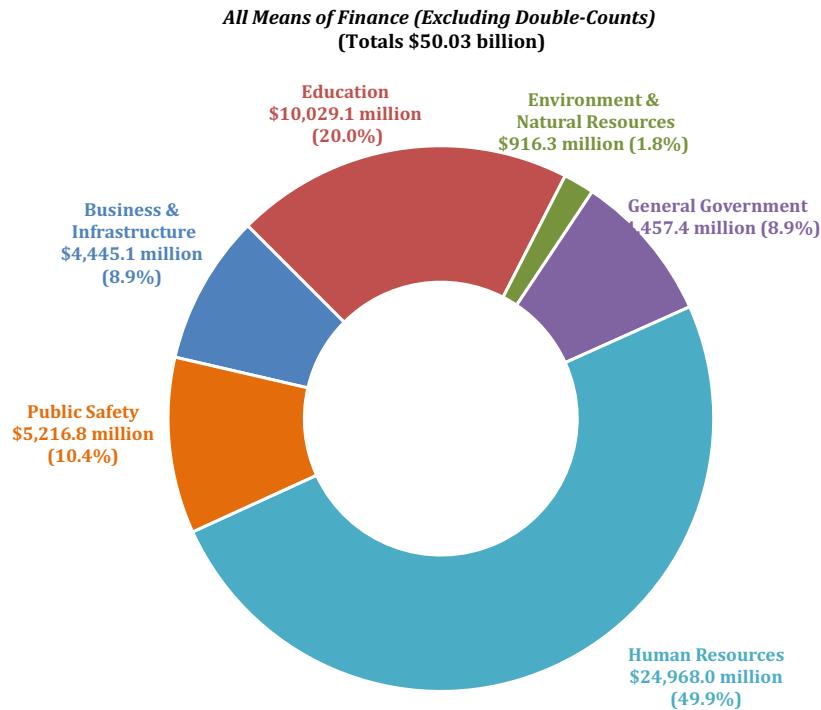


FY 2026-2027 Recommended Federal Funded Expenditures by Functional Area

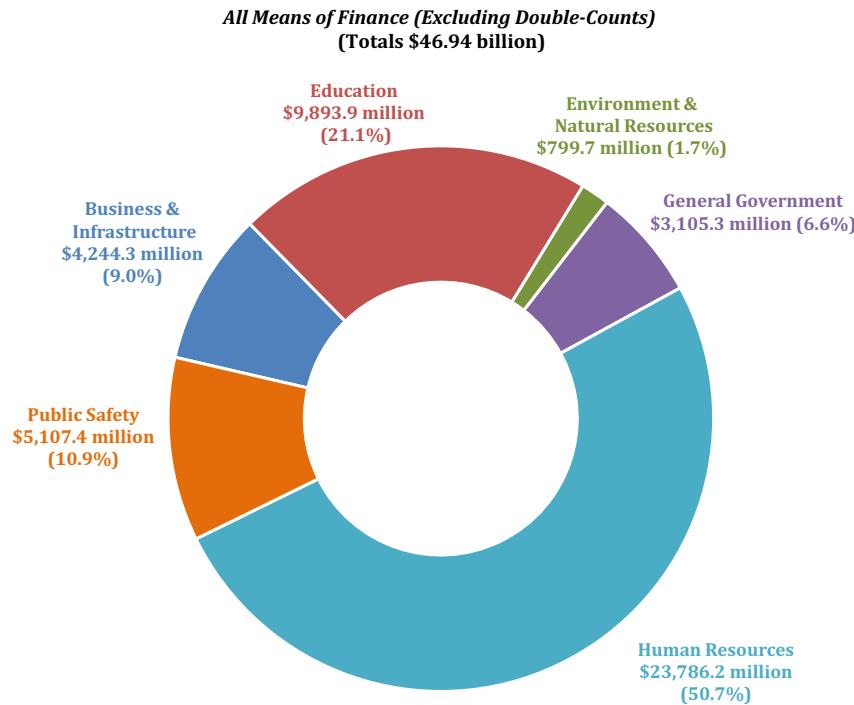

FY 2026-2027 Recommended Total Expenditures by Functional Area





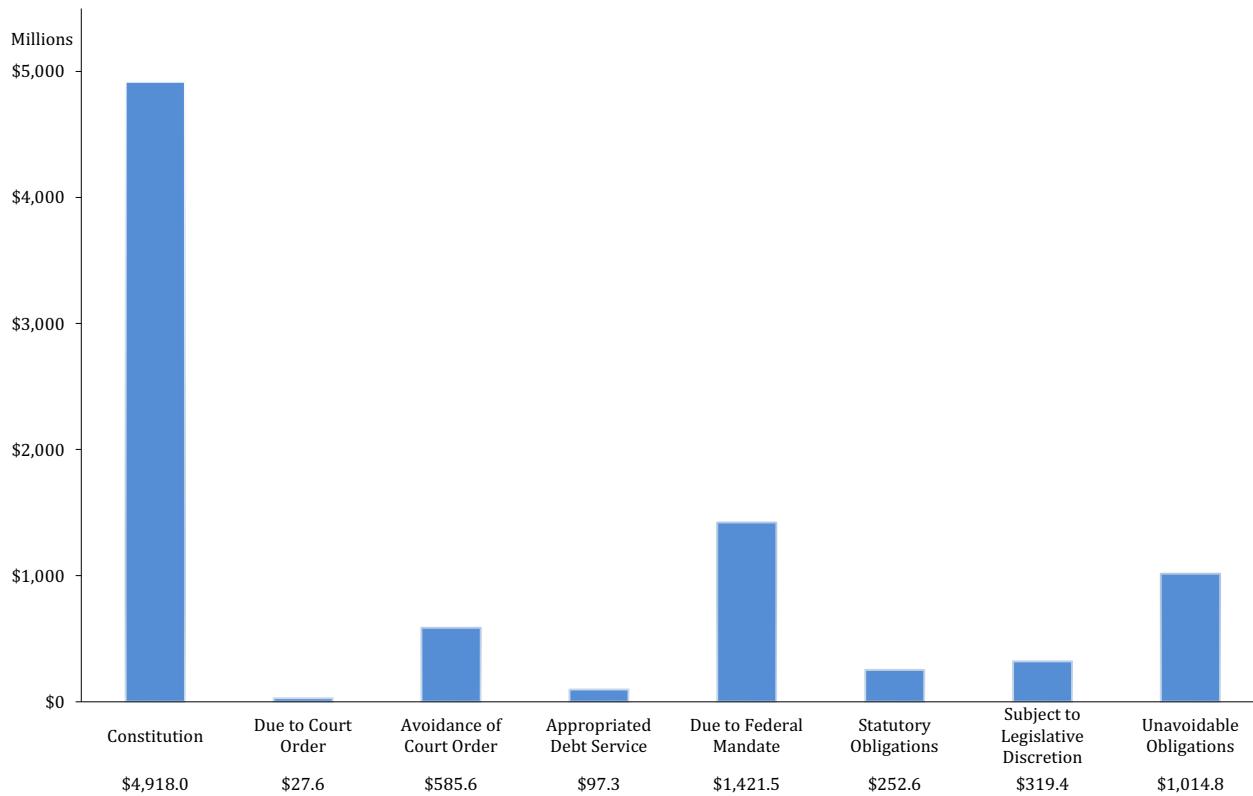

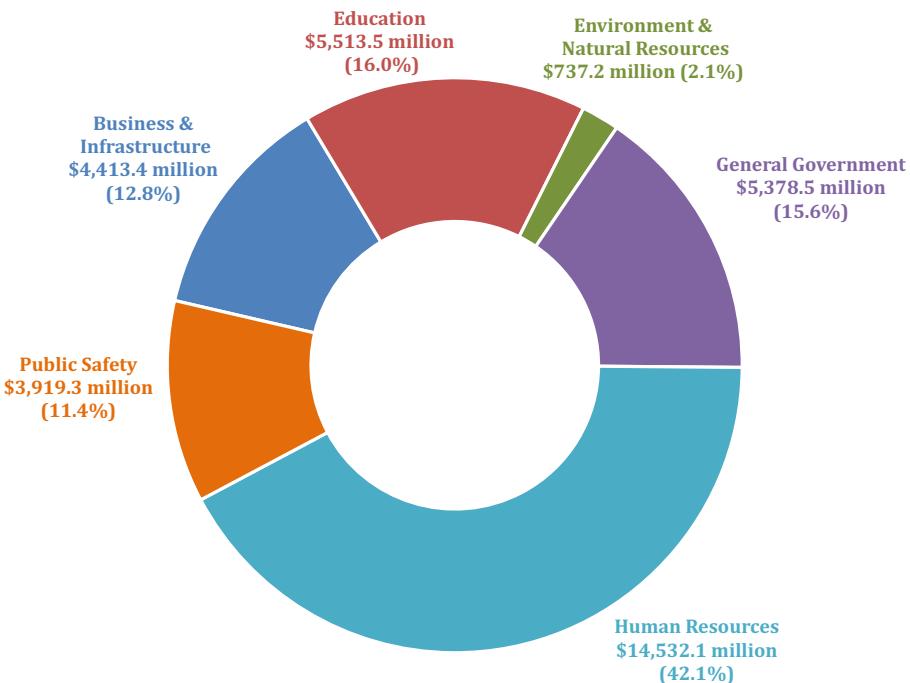

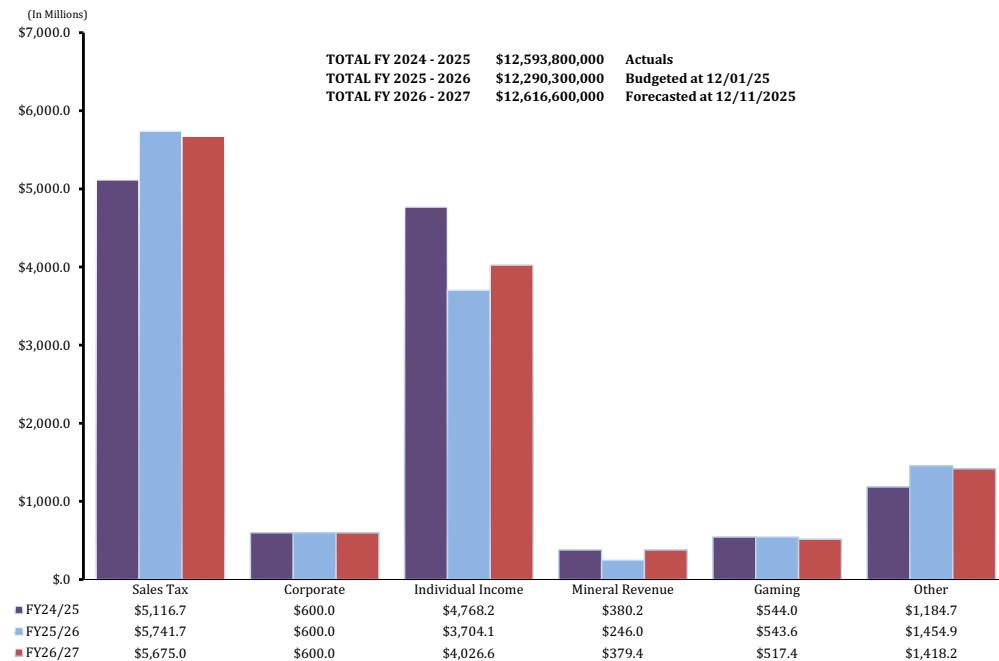

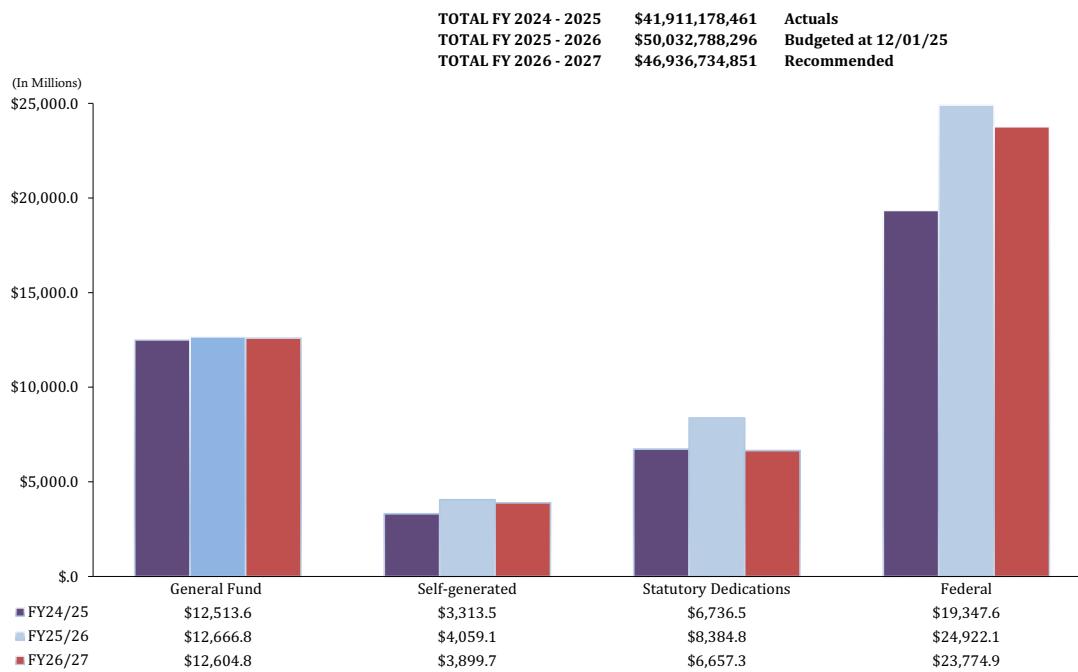

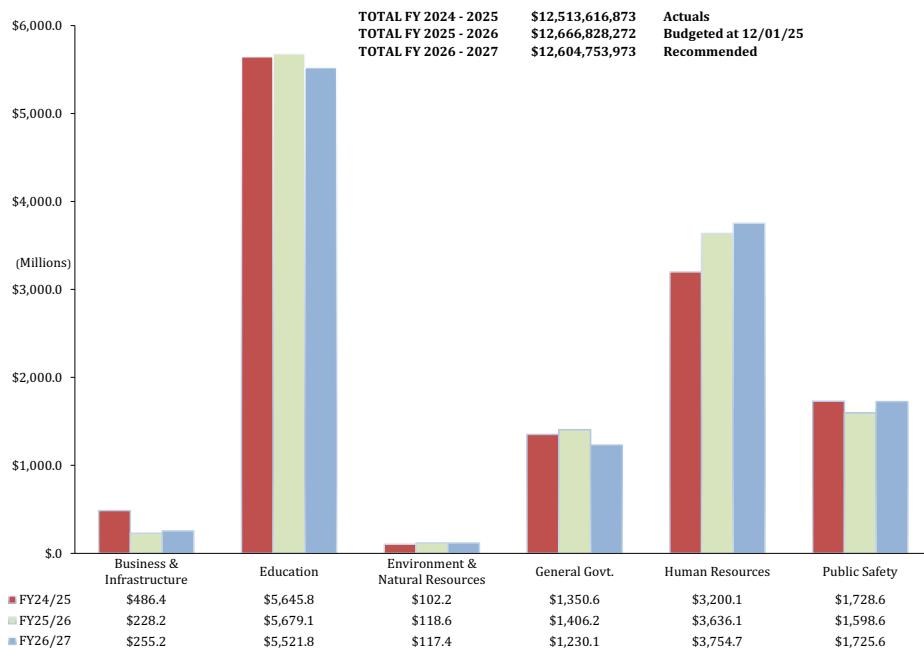
State General Fund Revenue



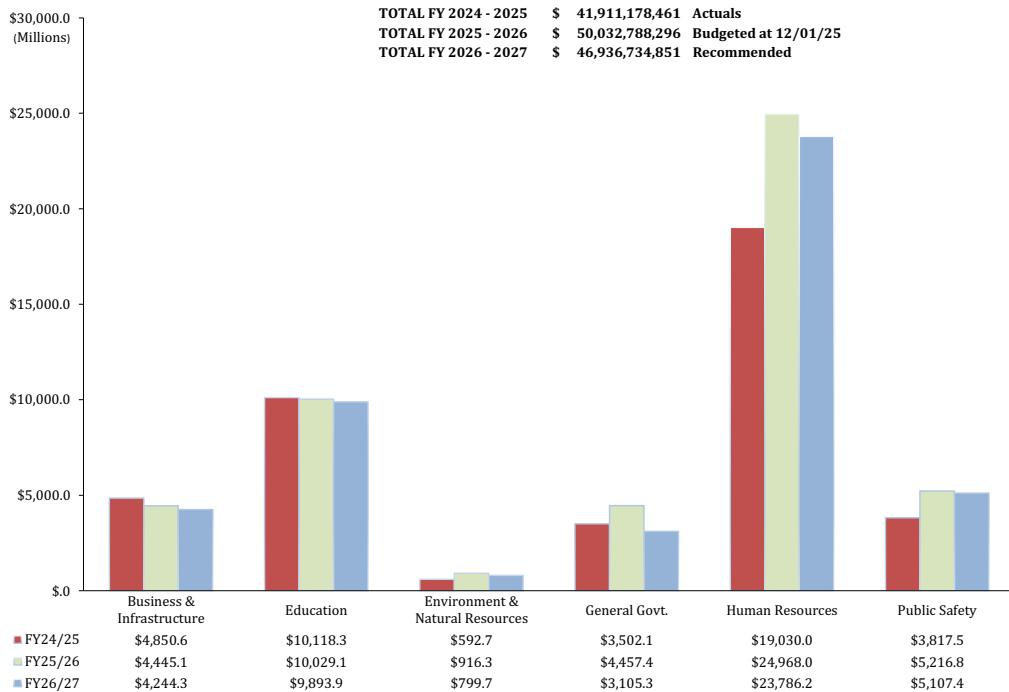
Total Means of Financing (Excluding Double Counts)

Budget Highlights

- \$2.7 million in Fees and Self-generated Revenues out of the Louisiana Entertainment Development Dedicated Fund Account supports education development initiatives, matching grants for Louisiana filmmakers, and a loan guarantee program. This includes a decrease of \$2.3 million in FY 2026-2027 to realign funding to projected expenditures.
- \$1.5 million in Federal Funds for the State Small Business Credit Initiative (SSBCI) Small Business Opportunity Program (SBOP) from the U.S. Department of the Treasury. Budget Highlights

- The Office of State Police has allocated funding for approximately 1,109 State Trooper Commissioned Officer positions, of which approximately 626 are assigned to patrol the state's roadways.
- \$3 million increase in State General Fund (Direct) for the Office of State Police for operational equipment such as Trooper Class A and B uniforms, duty belts, mobile radios, and mobile data terminals.
- \$2.45 million increase in Interagency Transfers from the Governor's Office of Homeland Security and Emergency Preparedness in the Operations Program of the Office of State Police for increased costs in maintaining the Louisiana Wireless Information Network (LWIN).
- \$427,230 increase in Statutory Dedications out of the Sports Wagering Enhancement Fund for three (3) authorized T.O. positions to form a dedicated unit that will conduct mobile sports wagering investigations.
- \$2.65 million increase in State General Fund (Direct) is included to finance the purchase of 215 replacement vehicles for the Office of State Police fleet. This funding will enable all vehicles to have fewer than 150,000 miles and allow the agency to initiate a five-year rotation schedule. As of November 2025, the state police fleet consisted of 1,992 vehicles consisting of patrol cars, unmarked units, and pool cars.
- A transfer of \$192,151 in Statutory Dedications out of the Riverboat Gaming Enhancement Fund and two (2) authorized T.O. positions from the Office of Management and Finance to the Office of State Police.

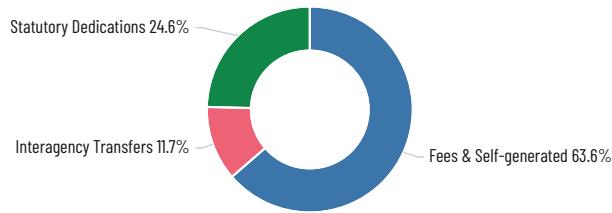

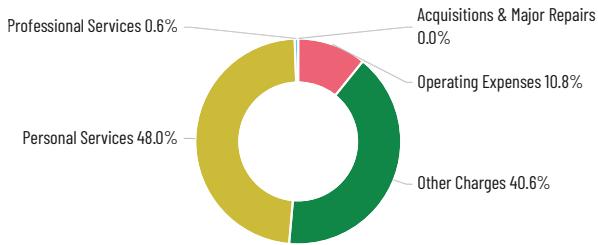

The Office of State Police enforces state laws relating to motor vehicles, streets, and highways of the state. - The Office of Juvenile Justice (OJJ) serves approximately 6,476 youth in community-based programs, probation and parole programs, and at seven (7) secure care facilities (Acadiana Center for Youth in Bunkie, Acadiana Center for Youth in St. Martinville, Bridge City Center for Youth in Jefferson Parish, Jetson Center for Youth in Baker, Swanson Center for Youth in Monroe, Swanson Center for Youth in Columbia, and Vernon Center for Youth).
- An increase of \$1.9 million in State General Fund (Direct) and 31 authorized T.O. positions ensures full operational coverage at the Jetson Center for Youth facility, providing 44 additional secure beds. The anticipated opening is April 2026.

The Office for Citizens with Developmental Disabilities includes the following programs:

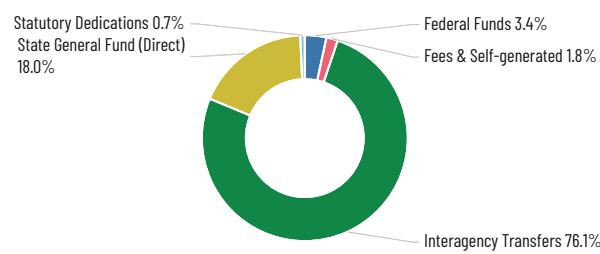
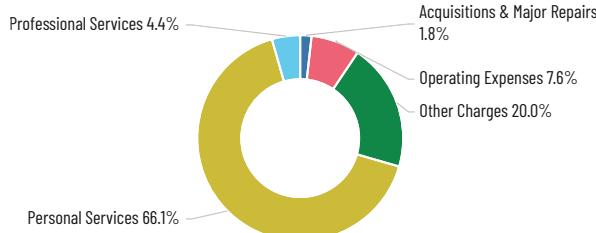
- **Administration Program** - Provides effective and responsive leadership of the developmental disabilities services system. The Administration Program provides system design, policy direction, administrative support functions, and operational oversight for the Resource Center, developmental disabilities waiver services, and state-operated supports and services centers. The Resource Center activity administers services whose primary functions include building community capacity, partnerships and collaborative relationships with providers, community professionals, other state agencies, educational institutions, professional organizations and other stakeholders to efficiently target

gaps and improve multiple efforts. Other services provided through the Resource Center activity include statewide supports and services to people who need intensive treatment intervention to allow them to remain in their community living setting. The closed facilities activity provides for ongoing costs associated with closed or privatized facilities.

- **Community-Based Program** - Manages the delivery of individualized community-based supports and services including Home and Community-based waiver services, through assessments, information/choice, planning and referral, in a manner that affords opportunities for people with developmental disabilities to achieve their personally defined outcomes and goals. Community-based services and programs include, but are not limited to, Family Flexible Fund, Individual & Family Support, Pre-Admission Screening & Resident Review, Single Point of Entry, Early Steps, and the four waiver programs (New Opportunities Waiver, Children's Choice Waiver, Supports Waiver and Residential Options Waiver), and the Money Follows the Person Demonstration Grant.
- **Pinecrest Supports and Services Center** - Provides for the administration and operation of the Pinecrest Supports and Services Center (PSSC) to ensure quality services and/or supports to the maximum number of individuals within the available resources. Supports the provision of opportunities for more accessible, integrated, and community-based living options. The Residential Services activity provides specialized residential services to individuals with developmental disabilities and co-morbid complex medical, behavioral, and psychiatric needs in a manner that supports the goal of returning or transitioning individuals to community-based options. Services include operation of 24-hour support and active treatment services delivered in the Intermediate Care Facility/Developmental Disabilities (ICF/DD) facility to services provided to persons who live in their own homes. This includes initial and ongoing assessment, psychiatric services, family support and education, support coordination and any other services critical to an individuals ability to live successfully in the community.
- **Central Louisiana Supports and Services** - Provides for the administration, instructional and residential needs of the Central Louisiana Supports and Services Center (CLSSC). The 24-hour active treatment facility operates as Louisiana's continuum of developmental disability services to provide specialized residential services to individuals with intellectual and developmental disabilities in a manner to support choice, dignity, and quality of life.
- **Auxiliary Program** - This program provides the residents of the Pinecrest Supports and Services Center with both paid work opportunities and/or therapeutic activities as recommended by an individual's support team.

Of this amount, \$36.3 million is allocated to child welfare services associated with foster care and prevention services; \$54.05 million for TANF initiatives, including LA 4, Court Appointed Special Advocates (CASA), Family Support, and Drug Courts; and \$73.07 million for core welfare services. Core welfare services consist of Kinship Care Subsidy Program (KCSP), Family Independence Temporary Assistance Program (FITAP), Strategies to Empower People (STEP) Work Supports, and Workforce Development.
- A reduction of \$6.24 million in State General Fund (Direct) and \$10.44 million in Federal Funds annualizes the One Door service delivery system created by Act 478 of the 2025 Regular Legislative Session, which transferred the following services from DCFS to the Louisiana Department of Health and Louisiana Works effective October 1, 2025: Supplemental Nutrition Assistance Program (SNAP), Family Independence Temporary Assistance Program (FITAP), Kinship Care Subsidy Program (KCSP), Disability Determinations, SNAP Employment and Training (SNAP E&T), and Strategies to Empower People (STEP) in order to streamline social services and workforce delivery.
- \$700,000 in Title IV-D Federal Funds is provided for the District Attorney (DA) Compliance Review project, which is a system designed to automate and standardize the oversight of child support cases currently managed under 38 separate DA contracts. The Louisiana Automated Support Enforcement System (LASESWeb) enhancements will automate creation of the review universe

from system data, covering all assigned and referred cases, standardize workflows for DA staff to document findings, track responses, report outcomes, provide dashboards and reporting to identify error trends, guide training, improve statewide compliance, and reduce manual labor. This will allow staff to focus on resolving errors and improving program performance, rather than gathering and assigning cases.

- \$5.4 million in Interagency Transfers from the Louisiana Department of Education is for daycare services for foster care children.
- Annualizes the FY 2025-2026 transfer of the Emergency Support Function (ESF) – 6 to the Louisiana Department of Health, Office of the Secretary by reducing \$4.66 million State General Fund (Direct). The ESF-6 responsibilities include coordinating mass care, emergency assistance, housing and human services during emergencies and natural disasters.
- \$2.26 million, of which \$1.7 million is State General Fund (Direct) and \$564,145 is Federal Funds, is provided for an increase in TIPS (Tracking, Information, and Payment System) Foster Care due to the number of paid days for restrictive and non-restrictive care settings.
- \$715,706, of which \$472,366 is State General Fund (Direct) and \$243,340 is Federal Funds, is provided for an increase in TIPS Guardianship as a result of a 17% increase in the number of children receiving guardianship subsidy payments and an increase in the number of service days.
- \$16.86 million, of which \$12.27 million is State General Fund (Direct) and \$4.6 million is Federal Funds, is provided to increase foster care board rates. This will allow Louisiana's foster caregivers to receive an increase in the monthly board rate that provides financial support for the care of children and youth in the state's custody, raising the average daily rate from \$19.47 to \$29.60. This also provides an increase in adoption and guardianship subsidies, which are paid at 80% of the current foster care board rate for eligible families.
- \$9.73 million, of which \$6.43 is State General Fund (Direct) and \$3.3 million is Federal Funds, is provided for the SABRE Project. This project will digitize approximately 95 million pages of child welfare records and aims to convert physical records into a secure, searchable digital, cloud-based format to improve caseworker access, reduce storage costs, enhance data security, and facilitate faster responses to law enforcement and legal requests.
- \$18.31 million, of which \$12.1 million is State General Fund (Direct) and \$6.21 million is Federal Funds, is provided for the Child Welfare System Modernization Project, which replaces the Comprehensive Child Welfare Information System (CCWIS). This project aims to improve Louisiana's child welfare system by consolidating legacy applications into a modern, centralized platform.
- Funding is provided for Binti software, which will support the Child Welfare System Modernization Project. The HomeReady Project aims to streamline and modernize foster and adoptive home certification by implementing Binti software to replace a paper-based system with a mobile-friendly digital platform. This initiative seeks to substantially reduce certification time.
- An increase of 53 non-T.O. FTE positions utilizes \$5 million in State General Fund (Direct) that was provided to the Division of Child Welfare during the 2025 Regular Legislative Session. DCFS utilized the funding to hire 53 Child Protective Services (CPS) investigator job appointments for a new second shift (1:30 PM-midnight, 4 days per week) to expand evening and weekend coverage for reports of child abuse and neglect, to address heavy caseloads and response delays.

Budget Highlights

- \$25 million reduction in Federal Funds is due to the Solar for Y'all grant being repealed by federal ruling.
- Reduction of \$125,868 in State General Fund (Direct) is due to savings and efficiencies identified throughout the agency. This includes a \$84,821 reduction in travel expenses due to additional approval requirements; and a \$41,047 reduction in Other Compensation due to scheduling reforms, pre-authorization thresholds, and risk-based deployment of inspectors.
- \$2 million reduction in Interagency Transfers is due to the consolidation of offices.
- Replaces 14 vehicles for a total of \$652,400. The funding includes \$480,300 in Fees and Self-generated Revenues out of the Coastal Resources Trust Dedicated Fund Account (\$50,000), and the Oil and Gas Regulatory Dedicated Fund Account (\$430,300); and \$172,100 in Federal Funds.
- \$2.22 million increase in State General Fund (Direct) provides the required state match for the following grants: LA Hubs for Energy Resilient Operations Project (HERO) grant; Preventing Outages and Enhancing the Resilience of the Electric Grid projects {40101 (d) grants}; and the State Energy Program grant.
- \$1.17 million increase in Statutory Dedications out of the Mineral and Energy Fund for two (2) new consulting contracts and annualization of the costs associated with the department absorbing the Capital Area Groundwater Conservation District.

431-Conservation and Energy

Agency Description

Executive – Provides the leadership, guidance, and coordination to ensure consistency within the Department as well as externally; promotes the Department, implements the Governor's and Legislature's directives and functions as Louisiana's natural resources ambassador to the world.

Conservation - Manages the conservation and development of the non-renewable natural resources in the state, while minimizing the negative environmental impact of the development. Ensures protection of public health and the environment from hazards associated with the transportation of hazardous liquids and with the exploration, production, transportation, distribution, and disposition of oil, gas, lignite and associated wastes and conservation of groundwater resources.

Mineral Resources – Prudently manages state-owned lands and water bottoms by managing and administering mineral and renewable energy assets in an environmentally-sound manner, primarily through the production and development of oil, gas, and alternative energy resources. These functions are performed under the authority and direction of the State Mineral and Energy Board.

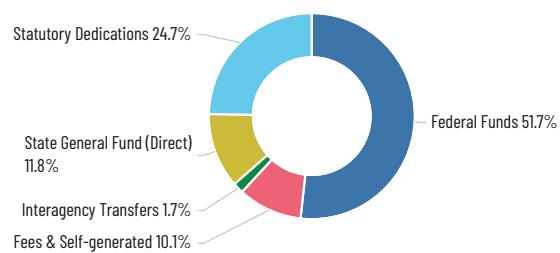
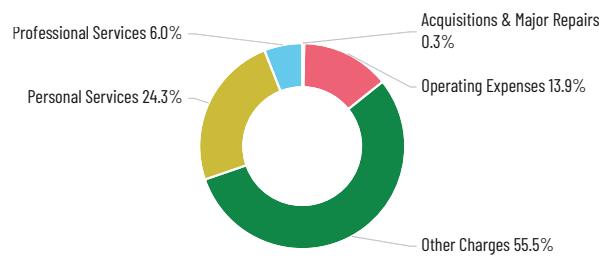
Coastal Management – Conserves, protects, manages, and enhances or restores Louisiana's coastal resources. Implements the Louisiana Coastal Resources Program (LCRP), established by Act 361 of the 1978 Louisiana Legislature. The LCRP is Louisiana's federally approved coastal zone management program. The Office of Coastal Management (OCM) also coordinates with various federal and state task forces, other federal and state agencies, the Office of the Governor, the public, the Louisiana Legislature, and the Louisiana Congressional Delegation on matters relating to the protection, conservation, enhancement, and management of Louisiana's coastal resources. Its clients include the U.S. Congress, legislature, federal agencies, state agencies, the citizens, and political subdivision of the coastal parishes in Louisiana's coastal zone boundary and ultimately all the citizens of Louisiana and the nation whose economy is impacted by the sustainability of Louisiana's coastal wetlands.

Manages a program that provides an opportunity to protect the correlative rights of all parties involved in the exploration for and production of oil, gas, and other natural resources, while preventing the waste of these resources.

The state legislature created the Louisiana Oil Spill Coordinator's Office (LOSCO) in 1991. LOSCO serves as the single point of contact for programs related to oil spills in Louisiana. LOSCO's mission is to minimize unauthorized discharges of oil, provide for an effective spill response, compensate the public for damages to the state's natural resources and services, and assist the public through education, service and public outreach.

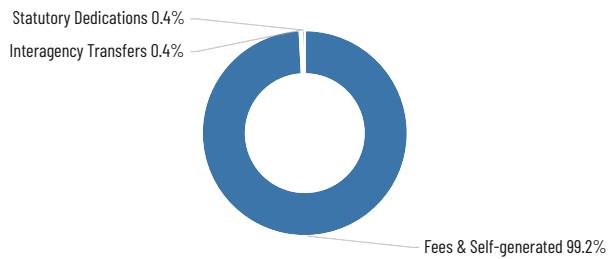

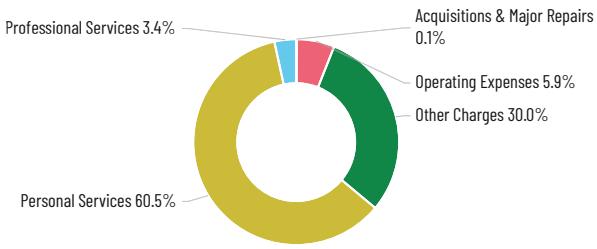

- \$1.83 million means of finance substitution increasing Fees and Self-generated Revenues out of the Environmental Trust Dedicated Fund Account and decreasing State General Fund (Direct) in the Office of Management and Finance to utilize the current available balance in the fund account.

856-Office of Environmental Quality

Agency Description

Secretary – The mission of the Office of the Secretary (OSEC) is to provide strategic administrative oversight necessary to advance and fulfill the role, scope and function of DEQ. As the managerial and overall policy-coordinating agency for the Department, the Office of the Secretary will facilitate achievement of environmental improvements by promoting initiatives that serve a broad environmental mandate, and by representing the Department when dealing with external agencies. OSEC will ensure the Department meets its performance and policy objectives by working and coordinating with all program offices.

Environmental Compliance – The mission of the Office of Environmental Compliance (OEC), consisting of the Surveillance, Emergency and Radiological Services, and Enforcement Divisions, is to protect the health, safety and welfare of the people and environmental resources of Louisiana. The OEC protects the citizens of the state by conducting inspections of permitted and non-permitted facilities, responding to environmental incidents such as unauthorized releases, spills and citizen complaints, and by providing compliance assistance to the regulated community when appropriate.

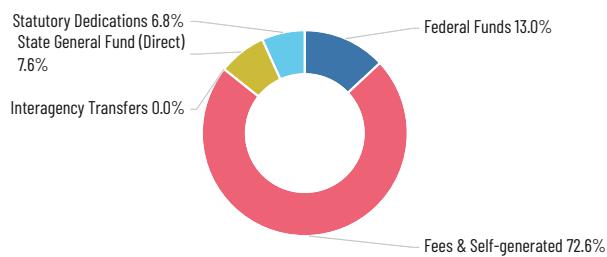
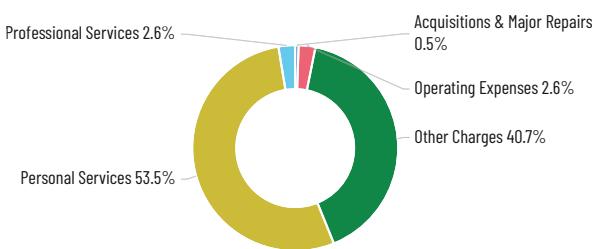

Agency Description

Workforce Support and Training strives to lower the unemployment rate in Louisiana by working with employers, employees, and government agencies to provide training, assistance, and regulatory services that develop a diversely skilled workforce. Workforce Support and Training consists of four (4) programs:

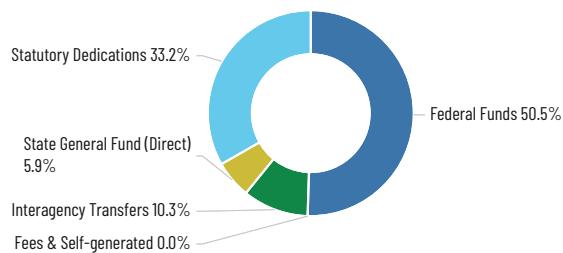
- **Office of Workers' Compensation Administration:** To establish standards of payment; to administer, review, and adjudicate injured worker claims; and to receive, process, hear, and resolve legal actions in compliance with state statutes. This office is also responsible for educating and influencing employers and employees in the adoption of comprehensive safety and health policies, practices, and procedures. Additionally, the office administers the Second Injury Fund, encouraging the employment, re-employment, and retention of workers with permanent partial disabilities by reimbursing eligible employers or insurers for qualifying workers' compensation benefit costs, and collecting assessments from insurance carriers and self-insured employers to support the program.
- **Office of Unemployment Insurance Administration:** To promote a stable, growth-oriented Louisiana economy through the administration of a solvent and secure Unemployment Insurance Trust Fund supported by employer taxes, and to ensure the timely and accurate payment of unemployment compensation benefits to eligible unemployed workers.
- **Office of Workforce Development:** To provide high-quality employment and training services, supportive services, and timely and accurate labor market information to employers, job seekers, customers, and stakeholders; to support informed workforce decisions; and to develop a diversely skilled workforce with access to good-paying jobs. This office also supports and protects the rights and interests of Louisiana's workers through the administration and enforcement of state worker protection statutes and regulations.

- **Office of Management and Finance:** To provide executive leadership, strategic direction, and centralized management of all departmental programs; to develop, promote, and implement policies, mandates, and administrative frameworks; to ensure fiscal integrity, operational efficiency, and regulatory compliance; and to provide technical and administrative support necessary to fulfill the mission of the Louisiana Works. This office is responsible for ensuring the quality of services provided, communicating departmental priorities, fostering effective relationships with stakeholders, and supporting department management, programs, employees, and external partners including the Division of Administration, federal and state agencies, local political subdivisions, citizens of Louisiana, and vendors.

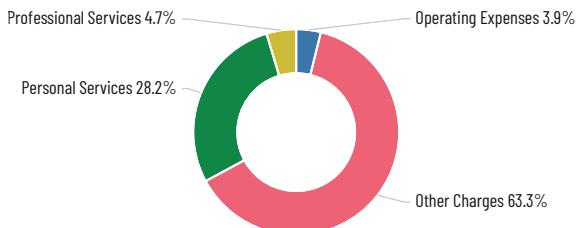

Budget Highlights

- \$222.41 million of funding, which consists of Fees and Self-generated Revenues of \$72,219, Statutory Dedications of \$92.13 million, and Federal Funds of \$130.2 million, for assisting clients in gaining employment, upgrading job skills in various industries, assisting clients with disabilities to gain employment and/or maintain current employment along with the underemployed workers in the state through federal Workforce Investment and Opportunity Act (WIOA), Unemployment Insurance (UI), Vocational Rehabilitation (VR), and other federal employment and workforce programs.
- \$56.32 million is for Louisiana Rehabilitation Services (LRS), of which \$12 million in State General Fund (Direct) is utilized as matching funds to draw down \$44.32 million in Federal Funds. The LRS is a career development and employment service offering quality professional outcome-based

vocational rehabilitation services on a statewide basis to eligible individuals, with the goal of successful employment and independence.

- \$35.71 million is for the transfer of family and support workforce development programs under the Strategies to Empower People (STEP) and Supplemental Nutrition Assistance Program Employment and Training (SNAP E&T) for a “One Door” service delivery system as mandated by Act 478 of the 2025 Regular Legislative Session. Funding is comprised of \$538,512 in State General Fund (Direct) and \$35.17 million in Interagency Transfers from the Department of Children and Family Services (DCFS) of \$21.77 million and Louisiana Department of Health (LDH) of \$13.4 million.
- \$26 million in Statutory Dedications out of the Incumbent Worker Training Program Fund provides grants for Louisiana businesses to partner with Louisiana-based training providers, delivering customized education to the awarded company employees.
- \$10.01 million is designated for Jobs for America’s Graduates (JAG), which consists of \$8.31 million in State General Fund (Direct) and \$1.7 million in Interagency Transfers from the DCFS, providing services to 9,200 students through 177 programs. A state-based, national non-profit organization, JAG is dedicated to helping high school students of promise who have encountered challenging or traumatic life experiences achieve success through graduation. As a resiliency-building workforce preparation program, JAG helps students learn in-demand employability skills, and provides a bridge to post-secondary education and career advancement opportunities.
- \$5.9 million in Federal Funds for continued support of the Help Individuals Reach Employment (HIRE) system. Funding covers consulting services/project management, additional infrastructure improvements including business continuity module upgrades, and programming fixes for system functionality. This automated unemployment insurance claim system is a modern web-enabled, fully-automated system. It is used to manage unemployment insurance claims and integrate with other systems, to provide workforce development services for job seekers, employers, and general labor market resources.
- Eliminates 36 authorized T.O. positions and associated funding of \$3.62 million, which consists of \$394,214 in Interagency Transfers from the DCFS, \$852,222 in Statutory Dedications out of the Office of Workers’ Compensation Administrative Fund, and \$2.37 million in Federal Funds, through natural attrition in accordance with Act 478 of the 2025 Regular Legislative Session.
- Eliminates two (2) programs, Office of the Secretary (OS) and the Office of the 2nd Injury Board (OSIB), and transfers the functions of those programs to the Office of Management and Finance (OMF) and the Office of Workers’ Compensation Administration (OWCA). The agency will operate through four (4) programs, allowing the agency to streamline the financial framework with the goal of creating a more unified strategy for delivering workforce and social service programs. The consolidation consists of:
 - \$4.55 million, consisting of \$72,144 in State General Fund (Direct), \$4,626 in Interagency Transfers, \$2.37 million in Statutory Dedications out of the following: Office of Workers’ Compensation Administrative Fund (\$548,721), Incumbent Worker Training Account (\$160,293), Employment Security Administration Account (\$435,964), and Penalty and Interest Account (\$1.23 million), and \$2.1 million in Federal Funds, as well as 23 authorized T.O. positions from the OS to the OMF; and
 - \$59.63 million in Statutory Dedications out of the Workers’ Compensation Second Injury Fund and 11 authorized T.O. positions from the OSIB to the OWCA.

- A net decrease of \$40.03 million in State General Fund (Direct) due to the following adjustments:
 - Non-recurs \$49.41 million for one-time adjustments received outside of the higher education funding formula;
 - \$5.27 million for increases associated with the LSU First Health Plan;
 - \$4.39 million for the Taylor Opportunity Program for Students (TOPS) as a means of finance substitution to provide State General Fund (Direct) and reduce Statutory Dedications out of the TOPS Fund based on the most recent Revenue Estimating Conference (REC) forecast;
 - \$4.19 million decrease in funding for statewide services, primarily due to rate decreases in the Louisiana State Employees Retirement System (LASERS) and Teachers Retirement System of Louisiana (TRSL), as well as risk management premium reductions;
 - \$4 million for a program management software platform for the Student Tuition Assistance and Revenue Trust (START) program, which helps support families to set aside funds for education and disability-related expenses with a tax-advantaged account;
 - A reduction of \$126,128 due to carryforward adjustments;
 - \$28,726 for the University of Louisiana Board of Supervisors for services provided by the Division of Administration; and
 - \$13,872 for Feist-Weiller Cancer Center at LSU Health Sciences Center – Shreveport.
- The TOPS awards program is funded at \$285.79 million, which consists of \$172.52 million in State General Fund (Direct) and \$113.27 million in Statutory Dedications out of the TOPS Fund. TOPS is Louisiana's merit-based scholarship program that awards qualifying students tuition payments for up to eight semesters at any eligible Louisiana institution.

- The Louisiana Go Grant Program continues to be funded at \$70.48 million in State General Fund (Direct). The purpose of this program is to provide a need-based component to the state's financial aid plan in supporting non-traditional and low-to-moderate-income students who require additional aid to afford the cost of attending college. These grants are designed to help bridge the gap between the total amount of other forms of aid a financially disadvantaged student is awarded and the cost of attendance at a Louisiana state university or college.
- The M.J. Foster Promise Program is funded at \$25 million in Statutory Dedications out of the M.J. Foster Promise Program Fund, this includes an increase of \$14.5 million in FY 2026-2027. The M.J. Foster Promise Program provides financial assistance to eligible students enrolled in qualifying programs at two-year public postsecondary education institutions or accredited proprietary schools. As determined by the M.J. Foster Promise Program Advisory Council, qualifying programs are those that provide a degree or requisite credential necessary for employment in high-demand, high-wage jobs which fall into one of five industry sectors that align with the state's workforce priorities.

The system is comprised of the campuses under the supervision and management of the Board of Supervisors of Southern University and Agricultural and Mechanical College as follows:

- **Southern University Board of Supervisors:** The Southern University Board of Supervisors shall exercise power necessary to supervise and manage the campuses of postsecondary education under its control to include receipt and expenditure of all funds appropriated for the use of the board and the institutions under its jurisdiction in accordance with the Master Plan; set tuition and attendance fees for both residents and nonresidents; purchase/lease land and purchase/construct buildings (subject to BOR approval); purchase equipment, maintain and improve facilities; employ and fix salaries of personnel; review and approve curricula and programs of study (subject to BOR approval); award certificates and confer degrees and issue diplomas; adopt rules and regulations; and perform such other functions necessary to the supervision and management of the university system it supervises.
- **Southern University-Agricultural & Mechanical College:** Southern University and Agricultural & Mechanical (A&M) College serves the educational needs of Louisiana's population through a variety of undergraduate, graduate, and professional programs. The mission of Southern University and A&M College, a historically black 1890 land-grant institution, is to: provide opportunities for a diverse student population to achieve a high-quality, global educational experience; to engage in scholarly, research, and creative activities; and to give meaningful public service to the community, the state, the nation, and the world so that Southern University graduates are competent, informed, and productive citizens.

- **Southern University-Law Center:** Southern University Law Center (SULC) offers legal training to a diverse group of students in pursuit of a Juris Doctorate degree. SULC seeks to maintain its historical tradition of providing legal education opportunities to under-represented racial, ethnic, and economic groups to advance society with competent, ethical individuals, professionally equipped for positions of responsibility and leadership, provide a comprehensive knowledge of the civil law in Louisiana, and promote legal services in underprivileged urban and rural communities.
- **Southern University-New Orleans:** Southern University-New Orleans (SUNO) primarily serves the educational and cultural needs of the Greater New Orleans metropolitan area. SUNO creates and maintains an environment conducive to learning and growth; promotes the upward mobility of students by preparing them to enter into new, as well as traditional careers; and equips them to function optimally in the mainstream of American society. SUNO provides a sound education tailored to special needs of students coming to an open admissions institution and prepares them for full participation in a complex and changing society. SUNO provides instruction for the working adult populace of the area who seek to continue their education in the evening or on weekends.
- **Southern University-Shreveport:** Southern University-Shreveport (SUSLA) primarily serves the Shreveport/Bossier City metropolitan area. SUSLA serves the educational needs of this population primarily through a select number of associate degree and certificate programs. These programs are designed for a number of purposes: for students who plan to transfer to a four-year institution to pursue further academic training, for students wishing to enter the workforce, and for employees desiring additional training and/or retraining.
- **Southern University-Agricultural Research & Extension Center:** The mission of the Southern University Agricultural Research & Extension Center (SUAREC) is to conduct basic and applied research and disseminate information to the citizens of Louisiana in a manner that is useful in addressing their scientific, technological, social, economic and cultural needs. The center generates knowledge through its research and disseminates relevant information through its extension program that addresses the scientific, technological, social, economic and cultural needs of all citizens, with particular emphasis on those who are socially, economically and educationally disadvantaged. Cooperation with federal agencies and other state and local agencies ensures that the overall needs of citizens of Louisiana are met through the effective and efficient use of the resources provided to the center.

Agency Description

- **University of Louisiana Board of Supervisors:** The Board of Supervisors for the UL System shall exercise power as necessary to supervise and manage the institutions of postsecondary education under its control, including: receiving and expending all funds appropriated for the use of the board and the institutions under its jurisdiction in accordance with the Master Plan; setting tuition and attendance fees for both residents and nonresidents; purchasing or leasing land and purchasing or constructing buildings subject to approval of the Regents; purchasing equipment; maintaining and improving facilities; employing and fixing salaries of personnel; reviewing and approving curricula and programs of study subject to approval of the Regents; awarding certificates, conferring degrees, and issuing diplomas; adopting rules and regulations; and performing such other functions as are necessary to the supervision and management of the system.
- **Nicholls State University:** Nicholls State University is a comprehensive, regional, selective admissions university that provides a unique blend of excellent academic programs to meet the needs of Louisiana and beyond. For more than half a century, the university has been the leader in postsecondary education in an area rich in cultural and natural resources. While maintaining major partnerships with businesses, local school systems, community agencies, and other educational institutions, Nicholls actively participates in the educational, social, and cultural infrastructure of the region. 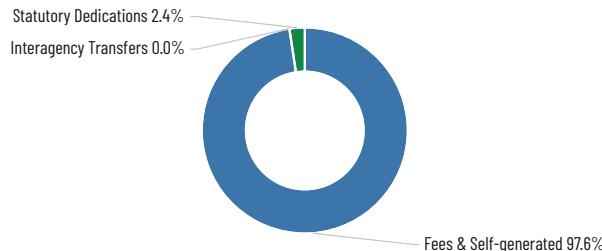

As an urban university serving the state's largest metropolitan area, UNO directs its resources and efforts towards partnerships with business and government to address the complex issues and opportunities that affect New Orleans and the surrounding metropolitan area.

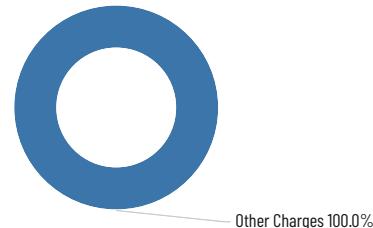

649-Louisiana Community & Technical Colleges Board of Supervisors

Agency Description

The Louisiana Community and Technical Colleges System (LCTCS) fosters collaboration and embraces economic development to provide leadership for its colleges, and matches their development and delivery of educational offerings to support the regional, state, and business economic development. LCTCS is comprised of the Board of Supervisors, seven (7) Community Colleges, five (5) Technical and Community Colleges, the LCTCSOnline, Adult Basic Education, and Workforce Training Rapid Response.

- **Louisiana Community and Technical Colleges Board of Supervisors:** Prepares Louisiana's citizens for workforce success, prosperity, continued learning, and improved quality of life. The Board of Supervisors of LCTCS provides effective and efficient management of the colleges within the System through policy making and oversight to educate and prepare Louisiana citizens for workforce success, prosperity and improved quality of life.
- **Baton Rouge Community College:** An open admission, two-year post-secondary public institution. The mission of Baton Rouge Community College (BRCC) includes the offering of the highest quality collegiate and career education through comprehensive curricula allowing for transfer to four-year colleges and universities, community education programs and services life-long learning, and distance learning programs. This variety of offerings will prepare students to enter the job market, to enhance personal and professional growth, or to change occupations through training and retraining. The curricular offerings shall include courses and programs leading to transfer credits and to certificates, diplomas, and associate degrees. All offerings are designed to be accessible, affordable, and of high educational quality. Due to its location, BRCC is particularly suited to serve the special needs of area business and industries and the local, state, and federal governmental complex.
- **Delgado Community College:** Delgado Community College provides a learning centered environment in which to prepare students from diverse backgrounds to attain their educational, career, and personal goals, to think critically, to demonstrate leadership, and to be productive and responsible citizens. Delgado is a comprehensive, multi-campus, open-admissions, public higher education institution providing pre-baccalaureate programs, occupational and technical training, developmental studies, and continuing education.
- **Nunez Community College:** Offers associate degrees and occupational certificates in keeping with the demands of the area it services. Curricula at Nunez focuses on the development of the total person by offering a blend of occupational sciences and the humanities. In recognition of the diverse needs of the individuals served and of a democratic society, Nunez Community College provides a comprehensive educational program that helps students cultivate values and skills in critical thinking, decision-making and problem solving, as well as prepares them for productive satisfying careers, and offer courses that transfer to senior institutions.
- **Bossier Parish Community College:** Provides instruction and service to its community. This mission is accomplished through courses and programs that provide sound academic education, broad career and workforce training, continuing education, and varied community services. The college provides a wholesome, ethical, and intellectually stimulating environment in which diverse students develop their academic and vocational skills to compete in a technological society.
- **South Louisiana Community College:** Provides multi-campus public educational programs that lead to: achievement of associate degrees of art, science, or applied science; transfer to four-year institutions; acquisition of the technical skills to participate successfully in the workplace and economy; promotion of economic development and job mastery of skills necessary for competence in industry specific to south Louisiana; completion of development or remedial cultural enrichment, lifelong learning and life skills.
- **River Parishes Community College:** River Parishes Community College (RPCC) is an open-admission, two-year, post-secondary public institution serving the river parishes. The college provides transferable courses and curricula up to and including certificates and associate degrees. RPCC also collaborates with the communities it serves by providing programs for personal, professional, and academic growth.
- **Louisiana Delta Community College:** Offers quality instruction and service to the residents of its northeastern twelve-parish area. This is accomplished by the offering of course and programs that

provide sound academic education, broad based vocational and career training, continuing educational and various community and outreach services. The college provides these programs in a challenging, wholesale, ethical, and intellectually stimulating setting where students are encouraged to develop their academic, vocational, and career skills to their highest potential in order to successfully compete in this rapidly changing and increasingly technology-based society.

- **Northwest Louisiana Technical Community College:** The main mission of the Northwest Louisiana Technical Community College (NLTCC) remains workforce development. NLTCC provides affordable technical academic education needed to assist individuals in making informed and meaningful occupational choices to meet the labor demands of industry. Included is training, retraining, cross training and continuous upgrading of the state's workforce so that citizens are employable at both entry and advanced levels.
- **SOWELA Technical Community College:** Provides a lifelong learning and teaching environment designed to afford every student an equal opportunity to develop to his/her full potential. SOWELA Technical Community College is a public, comprehensive technical community college offering programs including associate degrees, diplomas, and technical certificates as well as non-credit courses. The college is committed to accessible and affordable quality education, relevant training, and re-training by providing post-secondary academic and technical education to meet the educational advancement and workforce development needs of the community.
- **L.E. Fletcher Technical Community College:** L.E. Fletcher Technical Community College is an open-admission, two-year public institution of higher education dedicated to offering quality, economical technical programs and academic courses to the citizens of south Louisiana for the purpose of preparing individuals for immediate employment, career advancement and future learning.
- **LCTCSOnline:** A statewide centralized solution for developing and delivering educational programming online. LCTCSOnline currently provides over 50 courses and one full general education program for community college and technical college students. LCTCSOnline courses and programs are available through, and students are awarded credit, by an accredited LCTCS institution. LCTCSOnline develops and delivers courses and programs via a centralized portal where students can search a catalog of classes, choose classes, request enrollment and, once enrolled, attends classes. Students may order publisher content and eBooks, check their progress and see their grades in the same portal. To participate in LCTCSOnline, LCTCS colleges must be accredited either by the Southern Association of Colleges and Schools (SACS) or by the Council on Occupational Education (COE). Students who enroll in LCTCSOnline classes must first be admitted at an accredited college with the appropriate accreditation to offer the course or program. The college at which the student is admitted and will receive a credential is considered the Home College. The Home College will provide all student support services including program advising, financial aid, and library services. It is the policy of LCTCSOnline to use only eBooks where available, this results in significant cost savings to the student and assures that the course materials will be available on the first day of class. The goal of LCTCSOnline is to create greater access and variety of high quality programming options while containing student costs. LCTCSOnline will provide competency-based classes in which students may enroll any day of the year.
- **Northshore Technical Community College:** Northshore Technical Community College (NTCC) is a public, technical community college offering programs including associate degrees, diplomas, and technical certificates. These offerings provide skilled employees for business and industry that contribute to the overall economic development and workforce needs of the state. NTCC is dedicated to increasing opportunities for access and success, ensuring quality and accountability, enhancing services to communities and state, providing effective articulation and credit transfer to other institutions of higher education, and contributing to the development of business, industry and the

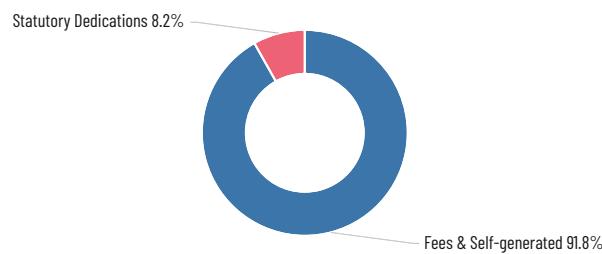
community through customized education, job training and re-training. NTCC is committed to providing quality workforce training and transfer opportunities to students seeking a competitive edge in today's global economy.

- **Central Louisiana Technical Community College:** Central Louisiana Technical Community College (CLTCC) is a two-year public technical community college offering associate degrees, certificates, and diplomas that prepare individuals for high-demand occupations and transfer opportunities. The college continuously monitors emerging trends by maintaining proactive business advisory committees and delivering on-time industry-based certifications and high quality customized training for employers. CLTCC pursues responsive, innovative educational and business partnership strategies in an environment that promotes life-long learning, and produces a knowledgeable and skilled workforce as well as confident citizens who grow viable businesses for the future. Using innovative educational strategies, the college creates a skilled workforce and prepares individuals for advanced educational opportunities.
- **Adult Basic Education:** Louisiana's comprehensive adult education program is designed to: 1) satisfy the basic literacy needs of adults; 2) improve and/or upgrade information processing skills and computational skills leading to a high school equivalency diploma or entry into postsecondary education; 3) satisfy the continuing education demands of adults in the current labor market; 4) improve the self-efficacy of adults; and 5) empower adults to achieve their goals. Through LCTCS, WorkReady U supports a diverse network of local adult education providers comprised of colleges, local school systems, and community-based organizations through the administration of grant funds, professional development and technical assistance, collaboration with workforce partners, and leadership development. Local adult education providers deliver courses and programs open to all adults who demonstrate a need for basic skill remediation in reading, writing, math, and English language proficiency. WorkReady U operates approximately 23 adult education programs in partnership with the community and technical colleges and other community entities across the state. These locations serve over 40,000 students annually in various learning programs: high school equivalency, literacy and numeracy education, English acquisition, and civics education.
- **Workforce Training Rapid Response:** Customized programs that are designed to quickly ramp up and mobilize training to respond to the fast-paced and changing nature of today's workplace. With rapid changes brought about by innovation, new occupations, and increasing technological skills needed to enter the workforce, the Workforce Training Rapid Response Program assists employers with unique training designed in a compressed nature that leads to academic awards and/or industry-based credentials required for employment. With a required business and industry match, the Louisiana Community and Technical College System ensures that programs are of high demand/ high wage nature by implementing programs that are related to the Louisiana Workforce Commission's Tier One, Four and Five Star occupation rating.

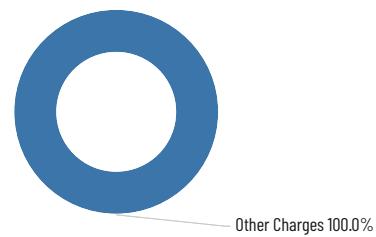

Agency Description

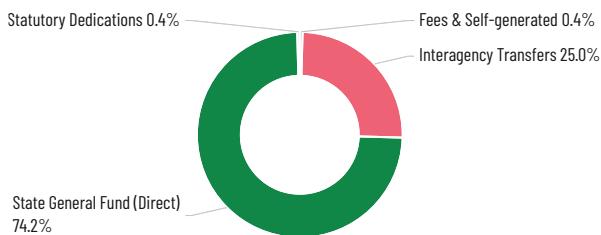
The Special School District strives to provide compassionate, collaborative, and innovative educational opportunities for students with low-incidence disabilities, meeting each student's unique needs. These schools are designed to provide students who are deaf/hard of hearing and/or visually impaired with a community of support that affords them the ability to hone their skills in American Sign Language (ASL) and Braille, respectively, by providing a culturally and sensory-rich environment. The Special School District has three (3) programs:

- **Louisiana School for the Deaf and Visually Impaired:** Provides educational services to blind and/or visually impaired children 3-21 years of age, as well as hearing impaired children 0-21 years of age through a comprehensive quality educational program that prepares students for post-secondary training and/or the workforce, and a pleasant, safe, and caring environment in which students can live and learn. This program will also provide administrative leadership and operational support covering executive, personnel, finance, purchasing, facilities, maintenance, food services, student health, transportation, technology, admissions and records, and appraisal services to ensure the effective delivery of services to schools.

- The cost to fully fund the current MFP formula, House Concurrent Resolution 23 of the 2022 Regular Legislative Session, remains at the existing level of \$4.02 billion in total funding.
- Means of finance substitutions based on the most recent Revenue Estimating Conference (REC) forecast resulted in a net \$1.31 million increase in State General Fund (Direct) due to the following: a \$508,000 increase in Statutory Dedications out of the Lottery Proceeds Fund, and a \$1.82 million decrease in Statutory Dedications out of the Support Education in Louisiana First (SELF) Fund. Total recommended funding is \$186.3 million in the Lottery Proceeds Fund and \$104.8 million in the SELF Fund.

 - \$2 million for Apprenticeships and Internships as an expansion of the Supplemental Course Allocation provision in Level 4 to support workforce development.

- State General Fund (Direct) of \$741,780 is provided for Ecole Pointe-au-Chien. This reflects an increase of \$361,740.
- \$199.47 million is removed for teacher pay stipends of \$2,000 for certificated personnel and \$1,000 for non-certificated personnel which is outside of the MFP Formula. This consists of \$174.14 million of State General Fund (Direct) and \$25.32 million of Statutory Dedications out of the Over-collections Fund.
