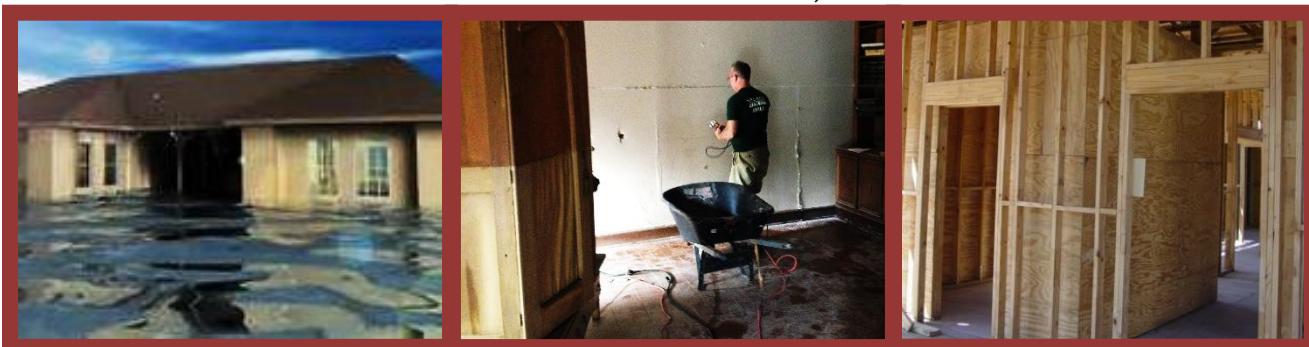

## **A. Summary of Changes**

The purpose of Action Plan Amendment 25 is to reallocate funding from programs that are reaching completion. The funding will be reallocated to administration and planning activities that will support closeout of the 2016 Floods grant and administration and planning of current and future disaster recovery initiatives.

The following programs will be decreased:

- Homeowner Assistance Program
- RLHP Flood Insurance Assistance Program
- RLHP Interim Housing Assistance Program
- Neighborhood Landlord Rental Program
- Neighborhood Landlord Program Phase II
- Neighborhood Landlord Program Phase III
- Resilient and Mixed Income Piggyback Program
- Rural Repair and Rehabilitation Program
- Middle Market Loan Program
- Small Business Loan Program

The following programs will be increased:

- Watershed Modeling and Planning
- Administration and Planning

One existing program description change is included for the Louisiana Military Dept – Affordable Rental Housing to accurately describe the final project.

Per the state's Master Action Plan, this amendment is considered substantial as the re-allocation of funds is more than \$5 million dollars and constitutes a change of 15 percent or greater of a program budget.

Budget change summary: The State administration and planning budget is being increased to support the continued management and closeout of the existing programs. This budget was created in Action Plan 1 and amended in APA 8 and 24.

### D. Existing Program Description Modification

This Action Plan Amendment No. 25 is modifying the Louisiana Military Department-Affordable Rental Housing Program (LMD-ARHP) description submitted in our substantial Action Plan Amendment No. 13. Within Action Plan Amendment No. 13, the state included the following description of the LMD-ARHP: "The existing housing will be demolished and replaced by at least 40 newly constructed homes that will be rented at affordable rates to military personnel and their families."

Through this amendment, the state amends this description to the following: "The existing housing will be demolished and replaced by at least 25 newly constructed homes that will be rented at affordable rates to military personnel and their families." The number of newly constructed homes were reduced due to the impact the COVID pandemic had on supply chain demands and construction costs. This amendment is required to clarify the program's number of beneficiaries.

### E. Public Comments

Per the state's initial Action Plan, this Amendment is considered substantial as the reallocation of funds is more than \$5 million dollars and constitutes a change of 15 percent or greater of a program budget. The formal public comment period for the amendment begins June 26, 2024 and runs until July 9, 2024. Citizens and organizations can comment on this amendment via:
