
# **CDBG-Disaster Recovery**

In 2020, Louisiana was hit by five named storms—including Hurricanes Laura and Delta—breaking the state's record for the most strikes in a single season. Additional storms hit Louisiana throughout 2021, with Hurricane Ida striking the state as a Category 4 hurricane, producing 150-mph winds, large amounts of rain and extremely high tides.

In September 2021, through the Disaster Relief Supplemental Appropriations Act, 2022 (Pub. L. 117-43), Congress appropriated \$650 million to Louisiana for recovery efforts related to Hurricanes Laura and Delta (2020).

Six months later in March 2022, Congress appropriated \$1.27 billion to Louisiana for Hurricane Ida and the May 2021 Severe Storms (2021), as well as an additional \$450 million for Hurricanes Laura and Delta, bringing the total allocation amount for recovery efforts related to 2020-21 disaster events to \$2.3 billion.

Congress then appropriated an additional \$831.5 million to Louisiana in September 2022, specifically for the 2021 disaster events (Hurricane Ida and the May 2021 Severe Storms), bringing the total amount to more than \$3.1 billion.

## **Programs Approved by HUD to Assist** With Recovery

#### Small Business Loan Program

The Small Business Loan Program provides partially forgivable, zero percent interest loans for non-construction expenses to eligible small businesses and nonprofits affected by 2020-21 disaster events. Participating nonprofit lender partners implement and administer the lending program to assist impacted businesses and nonprofits.

The application period for the program opened May 1, 2023. STATUS:

#### **Resilient Communities Infrastructure Program**

The Resilient Communities Infrastructure Program addresses unmet mitigation, business growth, economic and infrastructure recovery needs in impacted areas and improves resilient community planning and implementation.

The goal of this program is to reduce overall risk to people and structures from future storm events while also reducing reliance on federal funding in future disasters.



#### Non-Federal Match Program

The state provides federal or non-federal match funding for FEMA Public Assistance grants to offset the burden of local match requirements for infrastructure repair and rebuilding projects.

Eligible applicants may include parish and municipal governments, state agencies and authorities, schools (K-12) and universities, first responders and critical infrastructure facilities as defined by FEMA and public housing authorities.

The program provides the non-federal match for projects of \$1 million and greater for Debris Removal (Category A) and Emergency Protective Measures (Category B).

The application period STATUS: closed on June 30, 2023. ALLOCATION: \$240.8 million

#### **HMGP Global Match Program**

Program funds are used for a global match for eligible mitigation projects that would otherwise be unable to provide the required 10% non-federal match for Hazard Mitigation Grant Program projects approved by FEMA.

The goal is to reduce overall risk to populations and structures from future hazard events, while also reducing reliance on federal funding for future disasters.

Eligible projects may include acquisition of flood-prone structures, localized drainage improvements, safe room construction and wind retrofit of structures.

The state is reviewing applications submitted **STATUS:** to GOHSEP to identify projects for funding that

meet low-to-moderate income requirements.

ALLOCATION: \$77.3 million

#### **Local and Regional Watershed Projects and Programs**

The nine watershed districts of the Louisiana Watershed Initiative were created in 2018 to foster a regional approach to managing flooding.

LWI was funded by a separate mitigation grant, but funding to certain parishes was restricted due to federal rules.

This allocation provides funding for eligible parishes within the state's watershed regions 5, 6 and 8.

Funded through appropriated disaster recovery funds, this program supports mitigation efforts for regions 5, 6 and 8 under the Louisiana Watershed Initiative.

#### **STATUS:**

**Applications accepted** through late summer 2024.

#### ALLOCATION:

\$20 million

### Housing

#### Restore Louisiana Homeowner Assistance Program

The Restore Louisiana Homeowner Assistance Program provides grant funding to homeowners affected by the 2020-21 disasters for home repairs, reconstruction and/or work already completed. The program prioritizes helping low-to-moderate income residents and other vulnerable populations in their recovery process.

The first step in the process was to complete a program survey. Homeowners who met qualification criteria based on their survey responses were placed in phases for assistance and then invited to complete a full application.

#### **Eligible Activities**

Eligible activities under the Restore Louisiana Homeowner Assistance Program include:

- Home Repairs
- Home Reconstruction
- Manufactured Housing Unit Replacement
- MHU Repairs



- Reimbursement for Repairs Completed
- Voluntary Buyouts (Solution 4)
- Flood Insurance Assistance
- Interim Housing Assistance

#### **Program Summary to Date**

- **20,740** applications submitted, representing **81%** of the invited population.
- Of submitted applications, only 262 (1%) applications are still pending grant determination.
- 12,742 grant awards offered to homeowners, totaling \$930,376,429.16. Of those, 10,377 homeowners have closed on their grant agreements, obligating \$761,741,300.54.

The survey deadline ended Aug. 1, 2023, with the application deadline ending Oct. 31, 2023. STATUS: The program is underway in impacted areas throughout the state.



#### **Comparison to Other States**

Drawing from its wide experience in administering recovery programs, LOCD-DR has leveraged lessons learned and implemented best practices to launch programs that provide Louisiana homeowners with timely, effective and efficient recovery assistance.


When compared to other states who received disaster recovery funding under the Federal Register Notice, released Feb. 3, 2022, Louisiana was the first state to make progress in every category.





#### **EXPENDITURE COMPARISON**

- For 2020-21 disaster events, Congress appropriated a total of \$6.036 billion in CDBG-DR funding to 25 grantees.
- As of Aug. 1, 2024, grantees have drawn down \$666.81 million, totaling only 11%.
- Louisiana has drawn down 80% of the \$666.81 million, totaling \$535.44 million.
- 7 of the 25 grantees have not yet expended any of their available funds.



#### Supplemental Programs to the Restore Louisiana Homeowner Assistance Program

#### **Flood Insurance Program**

The Flood Insurance Program covers the costs of property flood insurance premiums for one year for eligible low-to-moderate income homeowners participating in the Restore Louisiana Homeowner Assistance Program. This assistance is supplemental to a Homeowner Assistance Program award grant and only available to Restore Louisiana program applicants.

#### **STATUS**

The program is underway, aligning with the Restore Louisiana Homeowner Assistance Program and open to Restore Louisiana applicants who qualify.

#### **ALLOCATION**

\$1.5 million

#### **Interim Housing Assistance Program**

This program provides up to 90 days of interim mortgage assistance for up to 20 months, or rental assistance for up to 20 months, to eligible low-to-moderate income homeowners whose homes are being reconstructed by the Restore Louisiana Homeowner Assistance Program.

#### **STATUS**

The program is underway, aligning with the Restore Louisiana Homeowner Assistance Program and open to Restore Louisiana applicants who qualify.

#### **ALLOCATION**

\$20 million

#### **Solution 4 Voluntary Buyout Program**

The Solution 4 Voluntary Buyout Program is available for Restore Louisiana Homeowner Assistance Program applicants who are located in floodways. The program is designed to move residents out of harm's way and help facilitate the natural watershed by improving local drainage and the resilience of impacted communities. Homeowners may also be eligible for a Resilient Housing Incentive if they relocate to homes outside the Special Flood Hazard Area. Each buyout is contingent upon acceptance of the disposition plan by parish where damaged property is located.

#### **STATUS**

The program is underway, aligning with the Restore Louisiana Homeowner Assistance Program and open to Restore Louisiana applicants who are located in a floodway and qualify.

#### **ALLOCATION**

\$20 million

## **Housing Match Program**

#### FMA-SWIFT (Non-Federal Share Match) Program

FEMA has provided GOHSEP with a Flood Mitigation Assistance Swift Current Grant to mitigate flood damage to substantially damaged and repetitively damaged structures from Hurricane Ida. These CDBG-DR funds will be used to offset the burden of the non-federal share match requirements faced by state and local entities and jurisdictions.

#### **STATUS**

The program is underway, aligning with GOHSEP's program requirements and amending the environmental reviews provided by FEMA.


# **CDBG-Mitigation**

### Louisiana Watershed Initiative

Following the 2016 floods, the state launched the Louisiana Watershed Initiative, introducing a new watershed-based approach to reduce flood risk in Louisiana. LWI coordinates funding, data and resources among state agencies, guided by the following principles:

- Using scientific tools and data
- Enabling transparent, objective decision-making
- Maximizing the natural function of floodplains
- Establishing regional, watershedbased management of flood risk

LWI was launched via Executive Order in 2018 and initially funded through a \$1.2 billion CDBG-MIT grant allocated to the state following the 2016 floods.



#### **LWI Initiatives and Progress:**


- Established nine provisional watershed regions, with steering committees guiding watershed-based flood risk management efforts among parishes and municipalities
- · Developing watershed models for each major watershed to assess flood scenarios and potential solutions, as well as enhancing the statewide river and rain gauge network
- · Launched a nature-based solutions training program, as well as a workforce development program to fund training for occupations critical to flood resilience efforts
- Facilitating property buyout and incentive programs in flood-prone areas across the state

#### On the Horizon:

- Model completion and public release
- Training for local and professional users for downloading and using regional models
- LWI-funded project timelines with projected construction and completion dates

#### The state has dedicated \$900 million to 127 flood mitigation projects throughout the state.

The state dedicated funding to 127 projects through LWI programs, including State Projects and Programs, Local and Regional Projects (Round 1, Round 2 and Design Support Program) and Non-Federal Cost Share Program (HMGP).

#### **LEVERAGING LESSONS LEARNED**

Based on program structure and planning efforts used to create the Coastal Protection and Restoration Authority, the state has tools and strategies needed to establish a statewide flood risk reduction program through LWI.

On Sept. 19, 2023, state and local government leaders broke ground on the \$1.4 million Bonadona-Cataldo drainage project in Donaldsonville, which was funded through LWI Round 1.
