Once you have determined which AFR packet is applicable to your entity, the applicable packet may be accessed via the internet at www.doa.louisiana.gov/osrap/index.htm.

The fiscal year ending June 30, 2015, AFR packets and Appendix can be located by selecting "AFR packets" within the "Information" box

- Scroll down and select the applicable AFR packet includes specific instructions applicable to that packet.
- Scroll down and select AFR Appendix should be used as a reference for the various AFR packets; however, not all of the appendices are applicable to all of the reporting entities.

Please note that discretely presented component units (DCUs) should no longer complete a Business-type Activities (BTA) AFR. DCUs should complete a Discrete Component Unit AFR packet, which has fewer note disclosures. OSRAP is no longer disclosing many of the DCU note disclosures in the State's CAFR, so it is no longer necessary to collect this data. ISIS agencies should complete an ISIS AFR packet unless otherwise indicated on the attached list.
