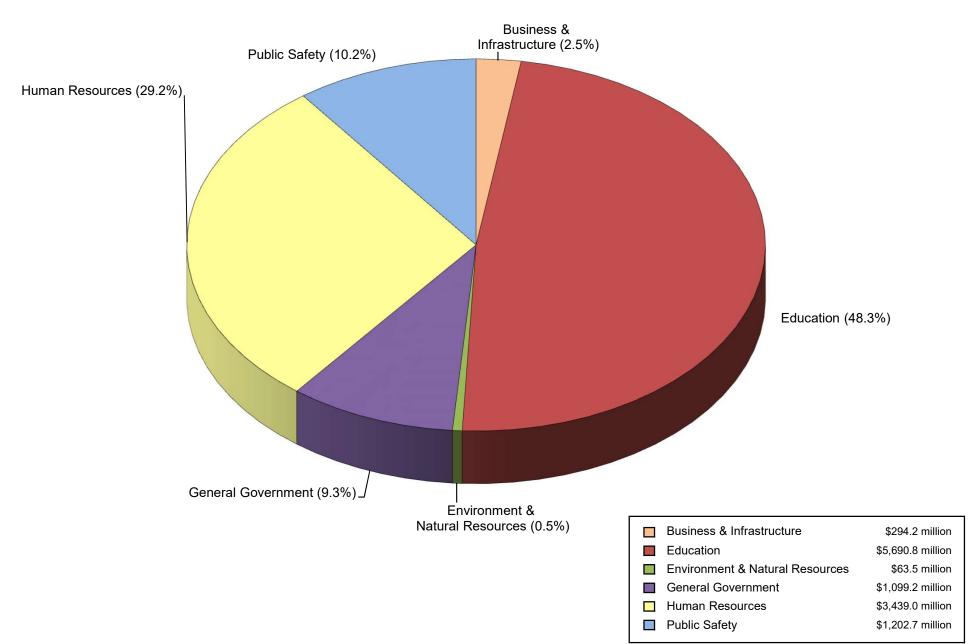

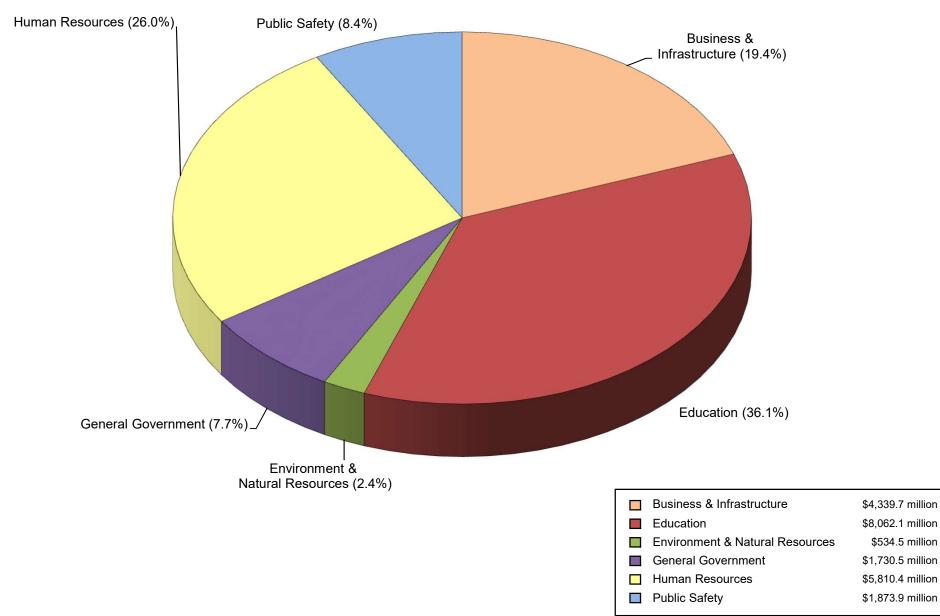

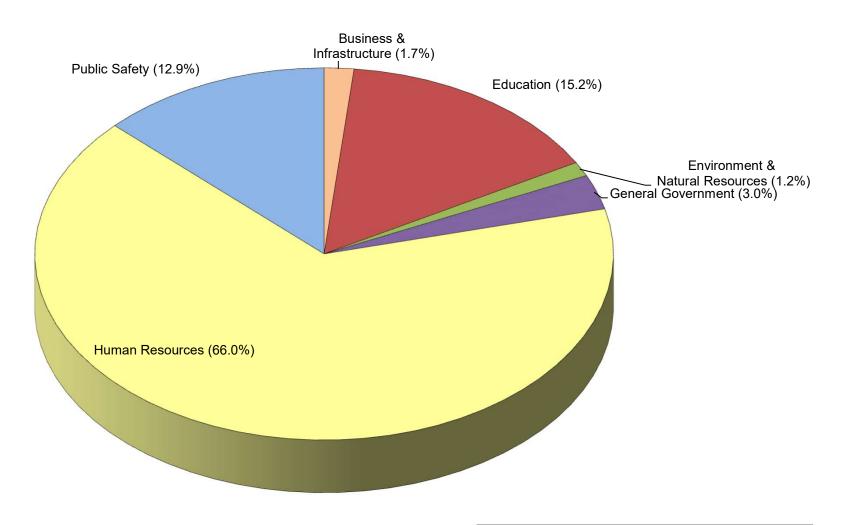
FY 2023 - 2024 Appropriated State General Fund Expenditures by Functional Area State General Fund only (Totals \$11.79 billion)

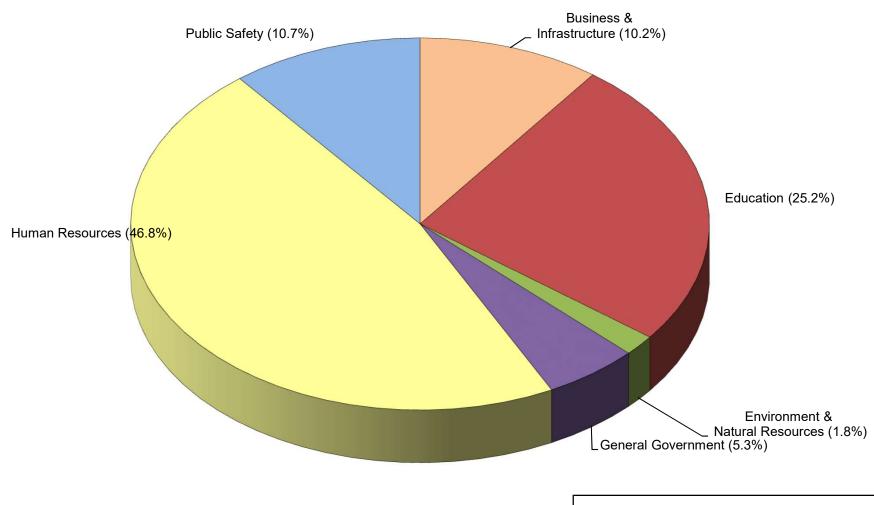


FY 2023 - 2024 Appropriated Federal Funded Expenditures by Functional Area Federal Funds only (Totals \$24.16 billion)



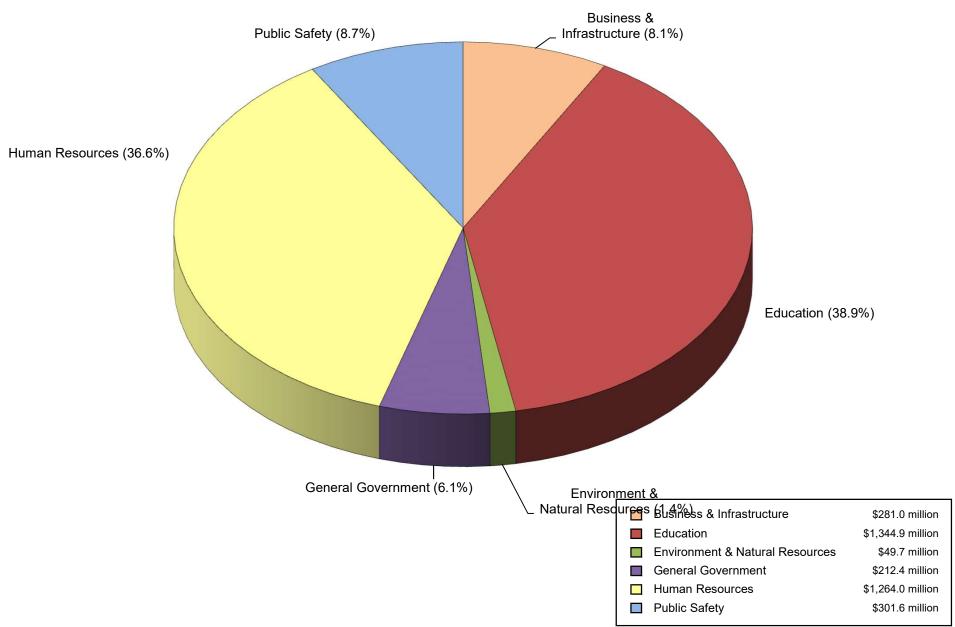

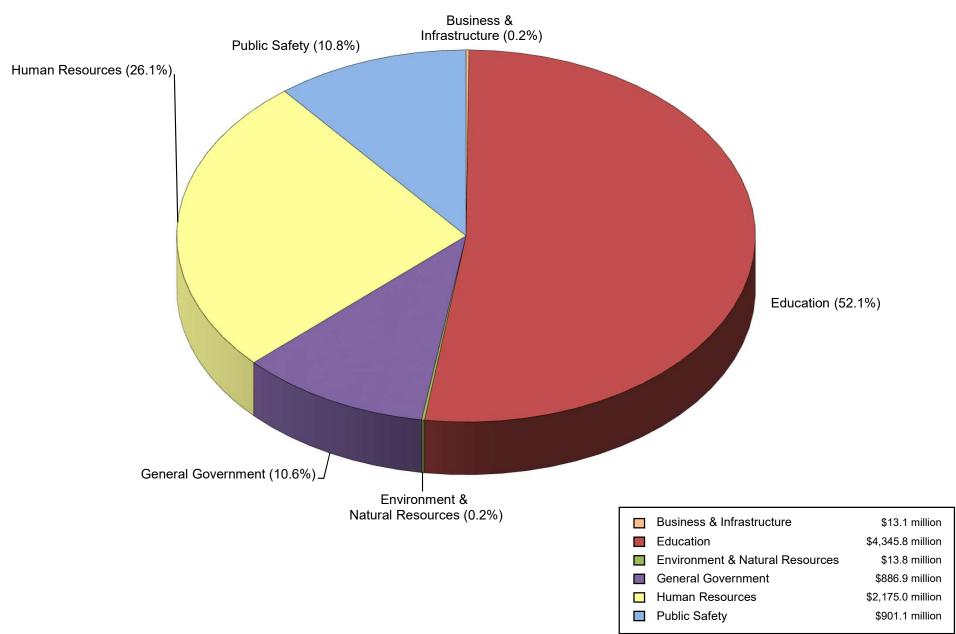

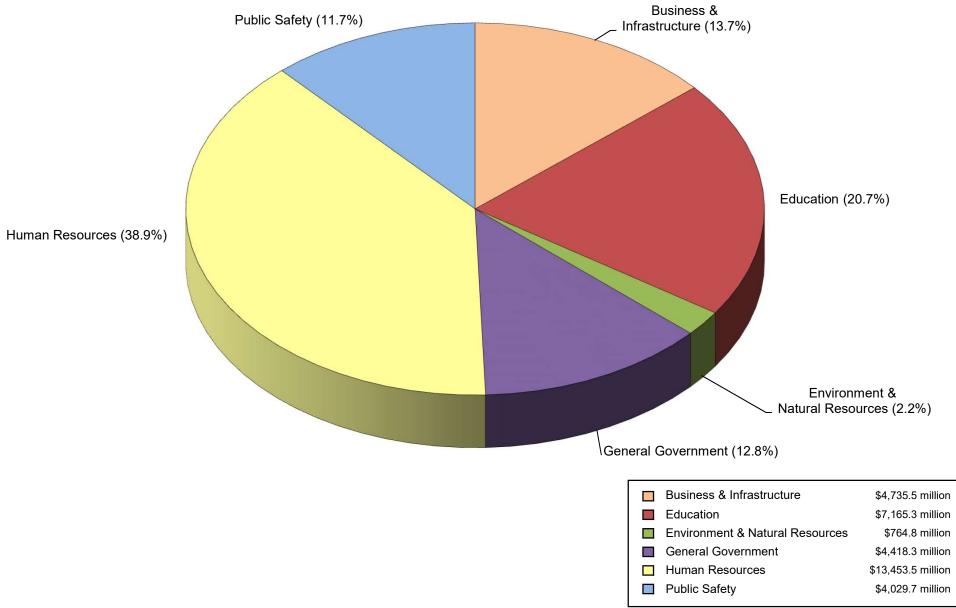
FY 2023 - 2024 Appropriated Discretionary State General Fund Expenditures by Functional Area State General Fund only (Totals \$3.45 billion)



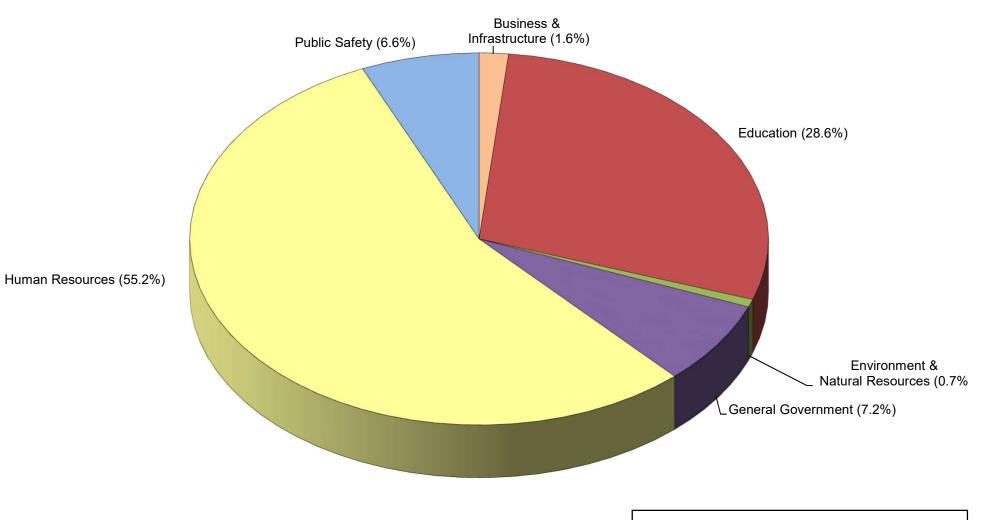
FY 2023 - 2024 Appropriated Non-Discretionary State General Fund Expenditures by Functional Area State General Fund only (Totals \$8.34 billion)
