**SCENARIOS**

1. Mary is a junior at ABC University. She has 1000 hours of state employment and 2500 hours\* of employment outside of the state. Mary's hourly rate of pay is **\$11.05**.

| <b>College Junior</b>  | 15 points        |
| <b>State Employment</b> (1000 hours)   | 1 point          |
| <b>Non-State Employment</b> (2500 hours) *<br>(A maximum of <b>1559 hrs.</b> is allowed) | 2 points         |
| <b>Total:</b>  | <b>18 points</b> |

\* A maximum of **1559 hours (2 points)** work experience gained outside of state government will be creditable.

2. John is a sophomore at ABC High School. He has 100 hours of state employment and 800 hours of employment outside of the state. John's hourly rate of pay is **\$9.00**.

3. Sue has 28 cumulative hours at XYZ Community College. She has 50 hours of state employment and 6000 hours\* of employment outside of the state. Sue's hourly rate of pay is **\$10.15**.

| <b>State Employment</b> (50 hours)   | 0 points         |

\* A maximum of **1559 hours (2 points)** work experience gained outside of state government will be creditable.

4. David is a senior at CBA University. He has 4685 hours of state employment and 1558 hours of employment outside the state. David's hourly rate of pay is **\$13.45**.

\* David **will only receive payment for 26 points**, because an employee is eligible for a **maximum of 10 points** for **total work experience**.

5. Jan is currently employed by the OHR. During the Spring of 2011, she was classified as a college junior and had worked a1000 hours of state employment and 1400 hours of employment outside of the state. Her current rate of pay is \$8.35. Jan's salary is being re-evaluated for the Spring of 2012 school session. She is now classified as a college senior. Since being evaluated in the Spring of 2011, she has worked an additional 1100 hours of state service and 100 hours of employment outside of the state. Jan's pay for the Spring 2012 school session is **\$12.25**.

|   |                  |
|---|------------------|
| <b>College Senior</b>                                       | 16 points        |
| <b>State Employment</b> (1000 hours + 1100 hours) = 2100    | 4 points         |
| <b>Non-State Employment</b> (1400 hours + 100 hours) = 1500 | 2 points         |
| <b>Total:</b>   | <b>22 points</b> |
